JOB: COLLECTION OF MATERIALS FROM BHEL/CLIENT'S STORES/STORAGE YARD; TRANSPORTATION TO SITE; ERECTION, TESTING, ASSISTANCE FOR COMMISSIONING, TRIAL OPERATION AND HANDING OVER OF BOILER AND AUXILIARIES INCLUDING ESP, ROTATING MACHINES, DUCTS & DAMPERS, FUEL PIPING, BOILER PIPING, POWER CYCLE PIPING ETC OF 1x250 MW UNIT # 8 AT TROMBAY THERMAL POWER PLANT, TATA POWER COMPANY LTD, MAHUL ROAD, CHEMBUR, MUMBAI 400074 MAHARASHTRA

Some of the agencies have sought clarification about certain clauses/sections of the Tender Specification for the job described above. These are being furnished as follows.

1. Deployment of 100 Ton Crane by Contractor for erection of ESP, Rotating M/s and Ducts etc: Please refer Appendix-III of the Tender Specification. We would like to clarify that 100 Ton crane with 70 meter long Boom and 18 meter long Jib will be necessary for erection of Boiler Structures till BHEL's 250/300 Ton crane (please refer Appendix-II of Tender Specification) is commissioned at site. In this context, we would like to convey that the elevation of ESP roof beam top is around 24 meters. Erection of ESP Structures and Casing can be done with 75 Ton crane. However ESP components above that elevation may be erected by derrick or any other suitable lifting arrangements/other crane.

For other systems / components like Rotating Machines, Duct etc, deployments of 75 Ton crane may be adequate.

Contractor shall have to deploy 100 Ton crane with specified Boom and Jib for those specific erection activities, which are not possible by a lesser capacity crane. In addition to the said 100Ton crane, one 75 Ton crane shall also to be deployed by the contractor for general erection purpose for sufficient duration.

2. Scope with regard to Chemical Cleaning Equipment and Spare Parts for their Servicing & Repair: Clause No. 7.4.2 of Special Conditions of Contract (SCC) deals with servicing and repair of BHEL's chemical cleaning equipments. The clause clearly indicates that spare parts for BHEL-supplied equipments will be supplied free of chargers by BHEL. Thus Spare Parts for contractor- supplied equipments shall be arranged by contractor.

Appendix-III, SN-8 of T.S. provides the list of equipments to be deployed by contractor. This does not deal with servicing/repair/Spare Parts, hence should not be referred for such purpose.

3. Scope of Supply of Chemicals for Chemical Cleaning: Please refer clause no. 4.2.3.H of SCC, inadvertently supply of chemicals has been indicated in contractor's scope. On the other hand, clause 5.4.4 and clause 7.5.1 of SCC stipulate that chemicals are in BHEL's scope.
