- a) The bidder should have successfully executed erection, testing and commissioning of total C & I system comprising of DCS / PLC, signal cabling, impulse pipe, LT Electrical equipments, control and power cables etc. in Thermal or Nuclear or Combined Cycle / Cogeneration Power Plant or any Petro chemical / Process industries in the last seven years
- b) The bidders should have a minimum average financial turn over of **Rs.90 Lakhs** per year in the preceding three years ending on 31.03.2006

The bidder must have earned profit in any one of the last three financial years ending on 31.03.2006 and should have positive net worth as on 31.03.2006.
