Following points relevant to the tender may please be noted and complied with:

- 2.0 The offer shall be submitted as per the instructions of tender document. Only One set of tender document signed by authorised company representative of bidder and stamped on each page shall be submitted as detailed further. Bidders to note specifically that all pages of tender document, including these NIT pages for this particular tender shall be submitted by them (after signing/stamping on each page) as a part of their offer. Price shall not be mentioned by them anywhere in the technocommercial portion of offer, it shall be mentioned in the relevant price schedule only and submitted in separate sealed envelope. In case of any clarification, bidder may contact this office. No alteration/changes/deviations by bidders is permitted in the tender/NIT enclosed herewith/ published in the website.
- 3.0 Last date of submission of offer is **15=00 hrs. on 29-01-2007**. Techno-commercial offer will be opened on next working day at 15-00 Hrs. which may be witnessed by bidder's representative.
- 4.0 You have to remit Rs. 1,250=00 towards cost of tender document (non-refundable, Rs. 1,000/- as tender cost + Rs. 250/- as postal charges (if applicable)) in the form of demand draft/pay order, drawn in favour of Bharat Heavy Electricals Ltd. payable at Kolkata along with the offer.

5.0 You have to deposit Rs 1,00,000.00 (One lac only) towards EMD in cash (as permissible under income tax act) / demand draft / pay order / Banker's chaque in favour of Bharat Heavy Electricals Ltd, payable at Kolkata.

Bidder can also opt to deposit Rs. 2 lakhs towards One time EMD which shall remain valid for all projects related tender (issued by BHEL, PSER, Kolkata) and EMD is not payable separately on tender to tender basis.

EMD in the form of Bank Guarantee is *not acceptable*.

- B) Your offer & documents submitted with the offer shall be signed and stamped in each page by your authorised representative. No overwriting / correction in tender documents by bidders shall be allowed. However if correction is unavoidable, the same may be signed by authorized signatory.

- C) All documents / annexures submitted with the offer shall be properly annexed and placed in respective places of the offer as per enclosure list mentioned in the covering letter. BHEL shall not be responsible for any missing documents.
- 7.0 No deviation with respect to tender clauses and no additional clauses/ suggestions/clarification in Techno-commercial bid/Price bid shall normally be considered by BHEL. Bidders are requested to positively comply with the same. Offers with deviation are liable for rejection.
- 8.0 BHEL reserves the right to accept or reject any or all offer without assigning any reasons thereof. BHEL also reserve the right to cancel the tender wholly or partly without assigning any reason thereof. BHEL also reserves the right to split/part award the job/award the jobs of different categories to different vendors. Also BHEL shall not entertain any correspondence from bidders in this matter (except for the refund of EMD). Issue of tender document to a bidder or submission of offer by a bidder does not automatically entitle the bidder for participation in the tender.
- 9.0 Since the job shall be executed at CESC Budge Budge site, West Bengal as elaborated in tender, bidders must visit site / work area and study the job content, facilities available, prevailing site conditions including law & order situation etc before quoting for this tender. They may also consult this office before submitting their offers, for any clarifications regarding scope of work, facilities available at sites or on terms and conditions. No additional claim shall be entertained by BHEL in future, on account of non-acquaintance of for above.
- 10.0 For any clarification on the tender document, bidders may seek the same in writing (two copies as per format annexure -IV of this NIT) within 16.01.2007, from the office of the undersigned which will be clarified to all the bidders. BHEL shall not be responsible for receipt of queries after due date of seeking clarification due to postal delay, and receipt of any query after due date shall not be entertained.
- 11.0 BHEL may decide holding pre-bid conference [PBC] with any / all intending bidders. On such communication from BHEL, the bidder shall ensure participation for the same at the appointed time, date and place as may be decided by BHEL. As such, bidders should plan their visit accordingly. In case of absence of any queries from bidder(s), the bidder(s) have to accept the clarifications given by BHEL on their own/query of other bidders as recorded without any query and the decision of BHEL shall be final and binding. Final quoted price of bidders will be PRESUMED to be quoted based upon the tender documents (including TCNs, if any) and such clarifications/pre-bid MOMs. Bidders are requested to study the tender documents in detail and prepare their queries/clarifications accordingly. All such queries / clarifications shall be cleared/ replied by BHEL. Such clarification letters and/or Tender change notes(TCNs) issued by BHEL/pre-bid MOM shall form part of tender document.
- 12.0 In the event of any conflict between requirement of any clause of this specification/ documents /drawings /data sheets etc or requirements of different codes/ standards specified/ contradictions between any two clauses of tender document, the same to be brought to the knowledge of BHEL by bidders in writing for clarification before due date of seeking clarification, otherwise, more stringent requirement as may be interpreted by BHEL shall prevail and shall be binding on bidders. Any typing error/missing pages/ other clerical errors in the tender documents, noticed by bidders must be pointed out before submission of offer, or else, BHEL'S interpretation shall prevail & binding on bidders.

- 13.0 Tender document containing above mentioned volumes shall be signed & stamped in all pages including this covering letter. Price bid shall be furnished in the format (Vol-III) enclosed with the tender. Any additional copy, if required, may be taken by photocopying from the tender document issued to bidders.
- 14.0 The Price Bids of only those bidders will be opened who will be qualified for the subject job on the basis of evaluation of Techno-Commercial bids / P-Q requirements / customer approval etc. BHEL reserves the right to reject a vendor with unsatisfactory past performance in the execution of a contract. BHEL's decision in this regard shall be final & binding.
- 15.0 **Purchase preference to CPSUs** shall be applicable as per government guidelines.
- 16.0 While BHEL reserve the right to open the price bid (Cover-II) of the offers in camera, the date & time to open the Cover-II (PRICE BID) tender opening shall be intimated to the bidders in case BHEL decides it to be `Public opening' and in such a case, one authorised representative of the bidder shall be allowed to attend.
- 17.0 Validity of the offer shall be for six months from the due date of offer submission (including extension, if any).
- 18.0 Tenders must adhere to the "special & specific conditions of contract alongwith annexures(Vol.-IE) and technical specifications and quote accordingly. Any terms and conditions not covered in this, will be governed by GCC (VOL-IB).
