2. The rate shall be entered in figures as well as in words. In case of difference in rates between words and figures, the lesser of the two will be treated as valid rate.

3. Only 'Unit Rate' shall be considered for evaluation and award.
4. In case of omission in quoting any rate, the evaluation will be done considering the highest quoted rate obtained against that item. But the work, if awarded, will be on the lowest quoted rate obtained against that item.
5. Items covered in above Sl. Nos. **6 and 7** are optional rates and shall not be considered for evaluation of tender.
6. The contractor while quoting the price / rates as above, categorically confirms having understood the fullest implications of the price escalation provisions contained in **clause** of this tender. Accordingly, taking into considerations all aspects thereof, quoted the above rates. Further the contractor confirms that he will not come up with any other claim / compensation on account of any increase whatsoever during entire period of execution including extended period, if any.
