Sealed Tenders (Under two part bid system) are invited from competent civil contractors for execution and handing over of Civil works of 400/220 KV Substation at Wardha in Maharashtra & 400kV Substation extension at Seoni in Madhya Pradesh. Only those who are technically and financially capable to execute the Job and who fulfil the Qualifying Requirements [QR] given under are eligible to quote against the above NIT. Tenderers should submit their offer in a sealed envelope as per the procedure specified in tender documents. The QR of contractor for tender submission shall be is as under:

A. Vendors should have a minimum average annual turnover of. **Rs..406 lacs** and should submit balance sheet and Profit & Loss Account for last three years ending 31.03.06

B. Vendor should have successfully executed/executing similar job (ref note below) during last seven years ending 28.02.07. Vendor should produce certification/proof in support of execution/executing similar package from user/end user and should be either of the following:

i. **Three similar completed/ executing works costing not less than Rs.541 lacs.**

OR

ii. **Two similar completed /executing works costing not less than Rs.676 lacs**

OR

iii. **One similar completed/ executing work costing not less than Rs.1082 lacs**

C. Vendor should have earned profit in at least one year during last three financial years ending on 31.03.06

NOTE: Similar job shall mean successful executed/executing of civil works of switchyard or substation or power house or industry /infrastructure predominantly concrete work.

Quotations received from bidders who do not fulfil the QR shall be summarily rejected without any further evaluation and information to bidders. Tenderers, who are not enlisted with Transmission Business Group, BHEL, should enclose all information required for a complete Evaluation & Enlistment in prescribed formats and other details as a proof of their credentials in a separate sealed envelope Superscribed " Request for Registration and enlistment" and submit prior to their offer along with Demand Draft of Rs. 1000/- in favour of BHEL, payable at New Delhi as application fee. The enlistment format is available on Web and may be downloaded.
