- 2. The component shall be manufactured through any one of the following processes:
 - a. Sand casting with proof machining
 - b. Investment casting
 - c. Centrifugal casting
- 3. The vendor shall have adequate experience in manufacturing high temperature stainless steel castings of a single piece weighing not less than 6.5 Kgs for supplying sl.no.1 &2 and 3.5 Kgs for sl.no.3&4 mentioned in pt.(1) above.
