EMD should be in the form of DD in favour of BHEL.

Eligibility criteria: (1) Contractor should have separate registration for EPF & ESI. In case of pending registration, the copy of application shall have to be submitted and registration to be obtained before commencement of work (2) Average annual financial turnover of similar works in the last three years should be 30% value of respective work (3) During last seven years should have successfully completed works either (i) Three similar works each of not less than 40% of the value of respective work or (ii) Two similar works each of not less than 50% of the value of respective work or (iii) One similar work of not less than 80% of the value of the respective work (4) Value of structural steel works completed in the last three years should be at least 30% of the value of the minimum required annual turnover as given in criterion (2) above. (This criterion is not applicable for work indicated against Sl.No.4) (5) Solvency shall be produced for at least 40% value of respective work.

All other details contained in the Tender Document which can be had from the undersigned by sending Demand Draft drawn in favour of BHEL for Rs.5630/- (Rs.5850/- if required by post) for each work for which application is required.
