- 3. Sub-contractors shall have supervisory license holder person and wireman permit holder technician to meet Indian Electricity Act requirement.
- 4. Sub-contractors are required to complete all parts of the application form and provide exhaustive information requested therein, to the satisfaction of BHEL. All the statement provided in the application form must be accurate and supported by documentary evidence as required.
