Qualification criteria for bidder

A) The bidder should have designed and executed at least one STP of minimum capacity 20 kld in the past 7 years and certificate for the satisfactory performance of the plant from the user shall be produced by the bidder. Final selection of the bidder is subject to approval of the customer M/s. **Karnataka Power Corporation Ltd. (KPCL).**

B) The bidders should have a minimum average financial turnover of Rs.33.60 lakhs in the last three financial years ending 31.03.2007.

C) Notwithstanding the above, BHEL reserves the right to reject any tender or all the tenders for the reasons whatsoever beyond out control and decision of BHEL is final.

D) Approval of the agency by the customer.

E) PURCHASE PREFERENCE TO Central Public Sector undertaking shall be operated as per Central Govt. Guidelines applicable on the day of Bid opening.
