QUALIFICATION REQUIREMENT

- The bidders should have executed material handling works such as receipt, unloading at site stores / storage yard, verification , stacking of materials / components, and preservation of materials etc., of 120 MW and above power plant equipments or handling of heavy equipments / components of any industries such as Petro chemicals, Steel plants, Aluminium Plants, Refineries, Fertilizer plant etc., in the last seven years.
- The bidders should have a minimum average financial turn over of **Rs.23.45** Lakhs per year in the preceding three years ending 31st March 2006.

The Bidder must have earned profit in any one of the last three financial years ending 31.03.2006 and should have positive net worth as on 31.03.2006.

Bidder should submit audited balance sheet and profit & loss account of the company for last three years ending 31.03.2006 in support of above requirement.
