Some of the bidders had sought clarification with regard to certain clauses of the Tender Specification. Point wise clarification is furnished as under;

#### 1. Appendix – I (Detailed Scope of Work):

Total weight of Boiler components included for this work is enclosed (four pages). Weight of other accessories of Boiler is as under

- a. Weight for Air Preheater Tubular 340MT.
- b. Electrostatic Precipitators 201MT
- c. Fans 200 MT

The above quantity and weight furnished is tentative and it may vary by +/-15%. Bidders are requested to calculate no. of joints as per Drawing.

Other queries are clarified as under:

**Query 1:** Tubular Air Pre heater will be supplied as blocks with tubes expanded or tubes are required to be expanded at site.

Clarification 1: We confirm that Tubular Air Pre heater will be supplied as blocks.

**QUERY 2:** Water Wall will be replaced as individual tubes or as panels; if they are in panel form, then what is the expected size and weight of individual panel. **Clarification 2:** Water Wall will be replaced as individual tubes.

**Clarification 3:** Some Panels are included in this scope of work.

**QUERY 4:** Total weight of Coal Piping not indicated in the weight schedule **Clarification 4:** Coal pipes are not to be replaced.

**QUERY 5:** It is presumed that Electrical and C&I work is not included in the scope of the subject tender.

**Clarification 5: Correct**, Electrical and C&I work is not included in the scope of the subject tender.

**Query 6:** Approximate quantity of grouting may please be indicated.

**Clarification 6:** Approximate quantity of grouting shall be about 6MT for both ID Fans in Unit-2. Grouting Cement – CONBEXTRA GP2

**Query 7:** Estimated area (Sq. Mtr.) of painting surface and DPT to be maintained may please be indicated.

**Clarification 7:** As per drawing, estimated area is 2000SQM.

**Query 8:** Cost of Construction Power per kwh.

**Clarification 8:** The present rate of Power tariff is Rs. 7 per Unit. But it is frequently changing time to time. The rate prevailing at the time of drawing Power shall be applicable. All other taxes and levies shall be as per Technical Bid clause 5.7.

**Query 9:** Sky climber should be made available (from GSECL/Ukai TPS).

**Clarification 9:** Sky climber shall be provided on Chargeable basis Depending on availability of same. Other wise, alternative arrangement is to be made by contractor.

**Query 10:** Percentage of Radiography Tests of High Pressure Joints not indicated clearly. Should we consider the same as per IBR Code.

**Clarification 10:** As per IBR, but if rejection is more, BHEL Engineer decision for more radiography shall be final.

**Query 11:** Accommodation for our Engineers & Supervisory staff may kindly be made available in the Township

**Clarification11:** Accommodation for your Engineers & Supervisory staff shall be provided on availability of same on chargeable basis.

We request the bidders to furnish unqualified acceptance of this clarification by submitting a copy of this duly countersigned by bidder's authorized signatory and stamped with official seal.
