QUALIFICATION REQUIREMENT

- The bidders should have successfully executed HT and LT Electrical works consisting of Generator Transformer, IP welded type of Bus Ducts of 12 KV class (as per IS 8084) and other related works like HT/LT Cable, LT Switch gear, Trays & Tray supports, earthing, etc, in a power station of minimum capacity of 60 MW in the last 7 years. And should possess valid license for high voltage electrical Installation related to the work.
- The bidders should have a minimum average financial turn over of **Rs.123** Lakhs per year in the preceding three years ending 2006.

The bidder must have earned profit in any one of the last three financial years ending 31.03.2006 and should have positive net worth as on 31.03.2006

The bidder should submit audited balance sheet and profit and loss account of the company for the last three years ending 31.03.2006 in support of above requirement.
