2.0 QUALIFICATION REQUIREMENT.

2.1 FOR CRANES UP TO 18T CAPACITY.

The agencies should have executed repair, maintenance, loading & unloading, commissioning and assembling of 8T Cranes or above in the last Seven years.

Average annual financial turn over during the last three years ending 31st March of the previous Financial year should be at least 8 (Eight) Lakhs

2.2 .FOR CRANES UP TO 75 T

The agencies should have executed repair, maintenance, loading & unloading, commissioning and assembling of 18T Cranes or above in the last Seven years.

Average annual financial turn over during the last three years ending 31st March of the previous financial year should be at least 15(Fifteen)Lakhs

2.3 FOR CRANES UP TO 150 T

The agencies should have executed repair, maintenance, loading & unloading, commissioning and assembling of 75T Cranes or above in the last Seven years.

Average annual financial turn over during the last three years ending 31st March of the previous financial year should be at least 15(Fifteen) lakhs

2.4. FOR CRANES ABOVE 150T ,FMC 250/325T CRANES AND UPTO 400 T

The agencies should have executed repair, maintenance, loading & unloading, commissioning and assembling of 150T Cranes or above and dismantling and assembly of Heavy Lift Assembly (Ringer) in the last Seven years.

Average annual financial turn over during the last three years ending 31st March of the previous financial year should be at least 12 (Twelve) lakhs

Envelope A super scribed with TECHNICAL BID and Envelope B super scribed with PRICE BID clearly mentioning Tender no and due date of tender opening on the envelope.

The Technical Bid cover shall consist of Demand draft of Rs 1.5 Lakhs (Rupees One Lakh Fifty Thousand only) towards EMD, Tender document cost of Rs 500/- (if documents down loaded from Web site),required documents for qualification requirements as per terms and conditions and NO DEVIATION CERTIFICATE from terms and conditions.

- 3.4. PRICE BID shall be submitted in separate sealed cover as per the Rate schedule enclosed in the Tender.**
