Sealed Tenders (Under two part Bid system) are invited from competent ETC contractors for execution and handing over of substations at Trombay. Only those who are technically and financially capable to execute the Job and who fulfil the Qualifying requirements [QR] given under are eligible to quote against the above NIT. Tenderers should submit their offer in a sealed envelope as per the procedure specified in tender documents. The minimum QR of contractor for tender submission shall be as under:

- a) Vendor should have average annual turnover of minimum Rs.13.0 Lakhs per annum for last three financial years ending on 31.03.07 Vendor should submit audited balance sheet and Profit & Loss Account for last three years ending on 31.03.07.
- b) Vendor should have successfully executed/executing similar job (ref note below) during last seven years ending 30.09.07. Vendor should produce Certification/proof in support of execution/executing similar package from User/end user and should be either of the following:
  - i) Three similar completed works each costing not less than Rs 17 lakhs.  

OR
  - ii) Two similar completed works each costing not less than Rs.21 lakhs.  

OR
  - iii) One similar completed work each costing not less than Rs 34 Lakhs
- c) Vendor should have earned profit in at least one year during last three financial years ending on 31.03.07
- d). The contractor should meet the minimum QR for T&P and testing equipments as per Annexure-I.

**NOTE:** Similar job shall mean successfully executed/executing erection, testing and commissioning of atleast 1 complete substation of 220 KV ratings and above.

Quotations received from bidders who do not fulfil the QR shall be summarily rejected without any further evaluation and information to bidders. Tenderers, who are not enlisted with Transmission Business Group of BHEL, should enclose all information required for Evaluation & Enlistment in prescribed formats and other details as a proof of their credentials in a separate sealed envelope superscribed " Request for Registration and enlistment" and submit prior to their offer along with Demand Draft of Rs. 1000/- in favour of BHEL payable at New Delhi as application fee. The enlistment format is available on Web and may be downloaded.
