The following clarifications is being issued with reference to queries by some bidders on 'T&Ps to be deployed by contractor'

Query-1:

Crawler / Tyre Mounted Crane with long range boom and JIB: Crane having capacity 200 MT, the cranes available in the market can not carry out the erection from 5th tier onwards as such we request that BHEL should provide HLHR crane for carrying out the erection from 5th tier onward.

Clarification to Query-1: TENDER CONDITIONS SHALL PREVAIL

Query-2:

Radiography Arrangement including the source: 2 sets each of IR 192 & COBALT 60 are shown to be provided by contractor. We would like to point out that COBALT 60 source which is normally used for ceiling girder is available with a single party only and it is not possible to deploy 2 sets COBALT 60, we would request a deviation that COBALT 60 only one set may be deployed.

Clarification to Query-2 :BHEL AGREES FOR ONE NO COBALT SOURCE.

Query-3:

Mobile Pick and Carry with Telescopic Boom: The capacity shown is 14 MT whereas normally pick and carry cranes available area up to 12 MT. Please confirm your acceptance of 12 MT capacity crane instead of 14 MT.

Clarification to Query-3: TENDER CONDITIONS SHALL PREVAIL
