01. Space for Kiosk:

The total number of open vacant spaces that would be allotted for kiosk on open tender basis are **four (04)** in numbers.

02. Period of allotment:

The spaces will be allotted on temporary basis for construction of temporary Kiosks for a period of one week. i. e. from **29.10.2021** to **04.11.2021**.

03. Earnest Money Deposit (EMD)/Security Deposit and Application Fee:

An amount of Rs. **1,100/-** should be paid through e Collect. (EMD amount of Rs.**1000/-** plus Application Fee amount of Rs.**100/-**).

04. Minimum reserve price:

The Minimum Reserve Price the period of one-week business i. e. from **29.10.2021** to **04.11.2021** is Rs. **20,000/-** plus applicable GST. **The Offers of bidders quoting less than the Minimum Reserve Price will be summarily rejected.**

05. Mode of Allotment:

The first open vacant space will be allotted to the bidder, quoted highest amount (H1). EMD PAYMENT WIDE E-COLLECT
