ANNEXURE-A

Terms and Conditions

01. Monthly hire charges of vehicle should be quoted by bidder **on the Price bid Format both in figure and Words**. Any overwriting in prices mentioned figure is not allowed. In case illegible price mentioned in figures, the price mentioned in words shall be taken in to consideration.
02. Daily normal duty hours will be for 12 hours i.e 8.00 AM to 8.00PM starting from reporting place and time. The detailed route of Vehicle shall be mutually decided with the Successful bidder.
03. Over time shall be payable per hour basis beyond normal duty of 12 hours per day @ Rs.70/- per extra hour. Part of the hour will be paid on pro-rata rate per minute basis i.e. Rs. (70/60) x extra minutes.
04. Fuel charges, shall be reimbursed as per the details @ ONE (01) litre of diesel for every **08 KM** running of Tata Winger/ Tempo Traveller (15+1) Seater Vehicle with AC.

Fuel charges shall be reimbursed @ ONE (01) Litre of diesel for every 10 KM running of Mahindra Bolero Neo –AC- Vehicle.

The reimbursement shall be made along with the monthly bill at the prevailing market rate of diesel of PSUs viz. IOCL, BPCL, HPCL etc.
05. Lubricant charges will be paid @ One Litre for every 500 KM run. For fraction of 500 KM, payment shall be pro-rated.
06. Monthly hired vehicle can be called for duty any time, so the vehicle cannot be engaged for any purpose other than BHEL.
07. Driver must report on duty in neat and clean uniform, free from intoxication and Contagious diseases with proper ID cards. Any change in driver shall be intimated by the vendor to the contract executing officer in charge for record and other compliances.
08. Driver must have a valid license and equipped with Mobile connectivity all the time round the clock.
09. The Vehicle must have neat & clean condition & must be washed on daily/Weekly basis for maintaining hygiene condition.
10. In order to avoid any kind of fire incidents and maintain safety features, Vehicle must have fire extinguisher and back horn. Fire Extinguisher must be refilled/checked as and when required by the agency, no charges for checking or refilling shall be payable by BHEL. Any other safety measures may be directed by BHEL and same shall be complied by the agency.
11. In case of exigency, vehicle may be required to be parked at locations decided by BHEL Officials without any additional charges.

12. The vehicle should report for duty in good condition, with Proper pressure in tyres, good condition of tyres and with adequate quantity of fuel.
13. In case, BHEL makes any payment towards repair/fuel charges, the same will be recovered from your bills with 30% overhead.
14. All taxes, insurance charges, local police allegations/law and order (if any) will be complied with/borne by owner. Making of all Gate passes

Originals shall be produced for verification purposes.
20. Tenderer will not be allowed to assign or transfer the contract to third party.
21. Payment will be made through RTGS/NEFT only once in a month **within 30 days** from submission of bill with all required documents as per prescribed format of BHEL. Bills should be accompanied with completed & signed log sheets signed by BHEL officials/representatives. BHEL reserve the right to terminate the services of vehicle contract anytime with a notice period of 15 days in writing during the contract period, if the service of vehicle/vehicles / driver / owner is found un-satisfactory.
22. It will be owner's sole responsibility to bear all the liabilities whatsoever on account of any loss or damage to any person or property in case the vehicle provided to BHEL meets an accident during duty hours during the contract period.

Liquidated Damages Penalties:

- The party has to deploy the required vehicles within 01 month of time from the date of award of work.
- The vehicles provided by the contractor shall be maintained in excellent running condition during the period of contract and the vehicle provided should be thoroughly washed and cleaned. The vehicle shall be used for local/outstation journeys by BHEL officials/Guests depending upon the requirement.
- Air-conditioning system (Cooling/heating) should remain in operation as per requirement of travelling officials. No extra charges will be paid for it (As per Applicable)
- Vehicle must be registered with concerned RTO shall be supplied to BHEL, TPS, Talcher Site and copies of proof of Registration certificate, road tax paid, insurances, Permit shall be submitted. - Copies of Renewal of insurance, road taxes, pollution certificate of Vehicles has to be submitted to the contracting department within 07 days of time from the date of expiry of the above. TAXES & DUTIES:
