b) The Tender % quoted as above will be applicable on total operations.
4. Any increases in Cost of Living Allowance / Wages shall be absorbed by the contractor himself and BHEL will not reimburse the increases in Cost of Living Allowance / Wages.
5. The estimate is inclusive of all other expenses and charges excluding GST, which will be paid extra with submission of documentary evidence and conforming to the GST clause as mentioned in clause no 2.1 above
6. Bonus as per statutory requirement/Bonus Act 1965, which- ever is higher, will have to be paid to the workmen by the contractor (**As applicable**). Bonus amount paid to workmen will not be reimbursed by BHEL.
