#### **Special terms & conditions of contract**

#### 1) SCOPE OF WORK:

Deployment of unskilled manpower along with tools & machineries for cutting, collecting and disposal of grass/bushes/trees. You have to deploy unskilled manpower for cutting, collecting and disposal of grass/bushes/trees. All necessary T&P like cutting tools, tractor etc. including consumables like fuel & others shall be in your scope. You have to deploy man heads as per requirement of the Site which shall be informed to you in 02 days advance. Proper photography evidence of the job done to be produced with the monthly RA bills.

#### 2) MOBILISATION:

You shall have to mobilize within 07 days from the date of intimation by BHEL authority.

#### 3) LABOUR GATE PASS & INSURANCE:

All Gate pass related formalities Shall be arranged by contractor. Any statutory requirement against deployment of labour against the above job shall be in your scope. BHEL, in no case shall reimburse any statutory liability to the contractor.

#### 4) CONTRACT PERIOD:

**SIX** months from the date of mobilization of manpower. Contract may be terminated at any time by giving 15 days prior notice without assigning any reason.

#### 5) CONTRACT PRICE:

You shall quote price for the aforesaid scope of work as per details given in Price Schedule (Annexure-III). Payment shall be made on the basis of mandays count only. The quoted price shall remain firm throughout the contract period. Your quoted price shall exclusive all taxes, duties & clearance fees.

#### 6) PAYMENT TERMS:

100% payment shall be released within 30 days after submission of bill along with certificate from concerned BHEL site engineer to the office of the Project Director/BHEL NTPC Barh site.
