The pre qualification bid (Part- A) will be opened on 25.07.2022 at 14:30 Hrs. at HRM Conference Hall, BAP, BHEL, Ranipet in the presence of tenderers / representatives who choose to be present for the tender opening.
- 3. Tenders will be evaluated further and the tenderers who are found to meet the pre- qualification criteria will be intimated to attend the tender opening of Part 'B'—price bid at a date to be notified separately. #### **SCOPE AND TERMS & CONDITIONS**

#### SPECIFICATION/ SCOPE OF WORK:

Services of photography/ video coverage of Official functions/ meetings held, at BAP, Ranipet. Photographs are to be generally supplied as soft copies in the form of DVD/Pen drive. The maxi size colour printed copies of the photographs along with soft copies in the form of DVD/Pen drive are to be supplied only when specially required by BHEL. Video coverage is to be supplied in the form of a DVD/Pen drive.

### **ELIGIBILITY CRITERION**

- 1. The tenderer should have established photo studio/ shop.
- 2. The photo studio/ shop must be located within 30kms from BHEL, Ranipet.
- 3. The tenderer should be a professional/ full time photographer or should have employed such persons.

#### **TERMS AND CONDITIONS**

- 1. Good HD quality and branded cameras (still/video) shall be used for the above work.
- 2. Date and Time of Photo / Video coverage and no. snaps / duration of the programme to be covered will be informed by the undersigned / PR staff. The photographer will not exceed the number of snaps as specified by BHEL in the request letter.
- 3. You shall be required to report at the venue for Photo / Video coverage when asked by the authorised person of BHEL / Ranipet within an hour.
- 4. The photography/ Video coverage shall be converted into DVD/Pen drive along with the relevant photo copies (if required) and delivered to BHEL/ PR dept. No payment will be made for the cost of DVD and conversion of the programme into DVD or transferring to a pen drive. A good quality DVD/Pen drive must be used for this purpose.
- 5. In case of urgency, photographs are to be delivered according to the nature of urgency at the shortest possible time as notified.
- 6. The entire photo/ Video with negative is sole property of BHEL. No photographs or DVD/Pen drive of BHEL/ Ranipet shall be parted to any person without the authorization in writing by the undersigned.
- 7. You are advised to maintain a record with specific Date, event, no. of copies requested, no. of copies delivered and the signature of the official to whom the photos / DVDs handed over. This may be required to be produced during the submission of bills by you.
- 8. The quantity indicated in the price bid is not "single time requirement", it is for the entire contract period i.e for two years. Also the quantity indicated in the price bid is tentative only. However, the actual quantum may vary according to the requirements and BHEL will not compensate any reduction in the quantity during the tenure of contract.

- 10. The Contractor's responsibility under this contract shall commence from the date of receipt of the order of acceptance of his offer through letter of intent.

- 12. Conveyance and Halting Charges per trip (irrespective of the number of hours of engagement in each trip) are to be quoted by the bidder in the price bid of the tender document. In case more than one trip in a day is requested, conveyance and halting charges will be paid accordingly.
- 13. Contract will be awarded to the lowest bidding tenderer i.e. L1 party. The L1 party will be decided base on overall basis of sum of the estimated quantity multiplied by the rate quoted for the respective item i.e based on S.No.7 of Price Bid. If more than one bidder emerges as L1, snap bidding will be done to decide the L1 party. No splitting of the contract will be done.
- 14. It is mandatory to comply with all taxes applicable for the required service. In the price bid, applicable GST in percentage is to be indicated separately. If it is not mentioned at the given place, it will be assumed that no GST is possible.
- 15. The contract shall commence from the date of awarding the contract or at a later date as decided by BHEL and shall remain in force for a period of two years. BHEL shall have the right to terminate the agreement for convenience without any liability whatsoever by giving one month's written notice.
- 16. In case of the matters not specifically provided herein, BHEL shall have the right to give instructions for compliance of the contract.

#### **VALIDITY OF RATES:**

The rates quoted shall be valid fior 90 days initially from the date of opening of the price bid. The rates of successful bidder shall be valid for two years from the date of commencement of the contract.

### **SECURITY DEPOSIT:**

The successful bidder shall be required to furnish security deposit at the rate of 5% of the order value within 3 days from the date of LOI.
