**1.SCOPE OF WORK**

1. Hiring 4 nos. of Tractors (Commercial Type 50 HP and above) with one driver and one helper per tractor for 12 hours. operation per day and 5 nos. of Trailers (12MT and above capacity) for 24 Hours operation.
2. The Tractors / Trailers are required for a contract period of ONE YEAR. The period of contract is likely to be extended subject to mutual agreement between BHEL and the contractor. In case of such extension, the terms and conditions and hiring charges agreed already will remain same for the extended period also.
3. The Tractors shall be operated for 12 hrs. per day normally from 06:00 hrs. to 18:00 hrs./ 08:30 hrs. to 20:30hrs. The reporting and releasing time for the tractor is likely to vary as per the requirements of BHEL. Tractors will be engaged on all working days and payment will be made for the actual number of days utilized/attended. However, if required, Tractors shall be engaged on Sundays/Holidays also, if required by BHEL.
4. The Trailers will be used for 24 hrs. in a day. In the trailer, the platform metal plate cover shall be in good condition without any damage. The wheel tyres shall also be maintained in good condition to carry the load safely. Also, the trailers shall be provided with side hooks for rope use and props for safe movement of load. Trailers will be utilized on all days including Sundays/holidays.
5. A Manila rope of size dia. 18 mm and length of 20 meters to be provided with each tractor by the contractor.
6. The vehicle shall be reported in full readiness for the entire day's operation in respect of fuel availability and readiness of the driver.
7. Tractor shall report to Transport section of M&S, and perform the duty allotted by the In-charge / Transport section.

**5. INSTRUCTIONS TO BIDDER**

1. The Tender is invited for 4 Nos. of Tractors (Commercial Type 50 HP and above), operating in good condition, with 1 driver, 1 helper for each tractor for 12 hours' operation per day and for 05 Nos of Trailers 1 (12MT and above capacity) for 24 Hours operation in a day.
2. The vehicle (s) should have been registered as commercial vehicle(s) with permit. Tractors with less than 50HP and Trailers with less than 12 MT capacities will be rejected.
3. The contract will be awarded to the technically acceptable, lowest offer on individual schedule wise basis. The loading pattern of hiring shall be decided for individual schedules (Tractor/Trailer) on the following basis.
  - i. From the technically qualified bidders, based on the Lowest standing (L1) in the price bid evaluation rating, the total quantity requirement will be ordered on L1, subject to L1 offer meeting the total quantity and fulfilling the tender conditions.
  - ii. In the course of evaluation, if more than one bidder happens to occupy L-1 status, effective L-1 will be decided by soliciting discounts from the respective L-1 bidders. In case more than one bidder happens to occupy L-1 status even after soliciting discounts, L-1 bidder shall be decided by a toss / draw of lots, in the presence of the respective L-1 bidder(s) or their representative(s) - If available, otherwise the same procedures will be carried out to arrive for L1 ranking). Ranking will be done accordingly. BHEL's decision in such situations shall be final and binding.
  - iii. In case the L1 bidder's original offered quantity is less than the requirement, for any short fall in meeting the overall required quantity, the finalized L1 rate will be counter offered in seriatim to the other bidders.
  - iv. However, counter offering L1 rate will not be made to all the bidders who quoted. The highest bidder(H1), who has quoted abnormal high rate compared to L1, will not be considered for counter offering if sufficient vehicles available for meeting BHEL requirement.
  - v. In the event of tie in L2 /L3..... Ln offers, the same procedure will be followed for ranking, as referred below.
    - a) Latest registered vehicle shall be ranked first.
    - b) If more than one vehicle is registered on the same date, existing contractor shall be ranked first.
    - c) If more than one existing contractor has offered same date registered vehicle, then preference will be given for performance of the contract and fitness of vehicle.
    - d) In the absence of previous/current performance records of first time bidders, the loading will be decided based on the other factors like vehicle model, and fitness conditions.
    - e) If the rank could not be finalized on the above (a) to (d), then the owner cum driver will be given preference.

1. The Tractors (Commercial Type 50 HP and above), operating in good condition, with 1 driver, 1 helper for each tractor is required for 12 hours' operation per day and for 05 Nos of Trailers 1 (12MT and above capacity) for 24 Hours operations.
