- 4.0 The quantities in this schedule are approximate and may vary to any extent or may be deleted altogether. The rate quoted against each item of the schedule shall remain firm till the contract value remains within "+" or "-" 15%.

1. SCOPE OF WORK:

Providing Manpower along with JCB and Tractor for Housekeeping, Drain Cleaning, Civil Structure Floor Cleaning and Removal of Structural, Boiler, Electrical & Other Scrap Materials at 1x660 MW Unit-5, Sagardighi Thermal Power Plant (Extension Project) for a Period of 60 (Sixty) Days.

The work is to be carried out as per relevant IS standards/specifications, and as directed by BHEL Engineer. All materials required for the job will be in the scope of successful bidder and as per tender document.

Required manpower, material, T&Ps, consumables and resources along with skilled and experience supervisor (s) for execution & completion of job as per BHEL requirement to be provided by the successful bidder

In addition to above, following are also in the scope of work of contractor:

- Labour license and group insurance of the workmen employed by the contractor and other statutory requirements shall be complied, as applicable, by the contractor.
- All labour rules, factories act, statutory requirements to be strictly adhered by the contractor.
- Arranging gate passes is in the contractor's scope, however BHEL shall provide necessary supports if required.

7. TERMS OF PAYMENT:

Payment Terms:

100% payment shall be released after satisfactory completion of the work in all respects and certification by the BHEL Engineer-in-Charge.

Payment shall be made within 30 days from the date of receipt of the correct and complete invoice at the BHEL site office, duly supported by the Engineer's Certificate/Joint Measurement Sheet and all applicable statutory documents, including Master Roll, Wage Sheet, ECR Challan, Labour Licence (where applicable) and any other relevant records.

Measurements shall be recorded and certified by the BHEL Engineer as per the relevant provisions of the GCC for the actual work executed. All statutory deductions, recoveries, taxes, duties, and other contractual adjustments, as applicable, shall be made from the bill.

Payment shall be made through RXIL mode. GST shall be reimbursed separately upon submission of valid tax invoice and supporting statutory documents, subject to compliance with applicable GST provisions.

9. COMPENSATION FOR DELAY:

Considering that this is a manpower supply contract for execution of housekeeping, drain cleaning and allied works throughout the power plant, including Wagon Tippler, Main Plant, ESP, Boiler, Water Package, Chimney, CW Pump House and other areas as directed by BHEL, timely deployment of the required manpower, equipment and resources is essential for uninterrupted project activities.

In the event the Contractor fails to deploy and maintain the required manpower, machinery or other resources, or fails to execute the assigned works as per BHEL's site requirements and schedule, thereby causing delay in execution, the Contractor shall, without prejudice to any other rights or remedies available to BHEL, be liable to pay Delay Compensation at the rate of 0.25% (one-fourth of one percent) of the total contract value for each week or part thereof of delay, subject to a maximum of 5% of the total contract value. The decision of BHEL regarding the occurrence and extent of delay shall be final and binding on the Contractor.

10. HEALTH, SAFETY & ENVIRONMENT:

Contractor has to comply with minimum HSE requirements as applicable for this Sagardighi U#5 Extn. Project.

11. TERMINATION OF CONTRACT:

If, at any stage during the execution of the contract, it is observed that the Contractor is not fulfilling the obligations stipulated under the contract or is failing to meet BHEL's requirements with respect to quality, progress, resource deployment, or timely completion of the work, BHEL reserves the right to terminate the contract.

Prior to termination, the Contractor shall be provided adequate opportunity for corrective action. For this purpose, BHEL shall issue a minimum of three (03) successive warning letters, each separated by an interval of at least one (01) day, highlighting the deficiencies and calling upon the Contractor to take corrective measures.

In the event that the Contractor fails to take satisfactory corrective action despite the aforesaid warnings, BHEL may terminate the contract by serving a three (03) days' advance notice. Upon such termination, BHEL shall be at liberty to engage an alternate agency for completion of the balance work at the risk and cost of the Contractor, and any additional expenditure incurred shall be recoverable from the Contractor as per the applicable contractual terms and conditions.
