1. The item of work as specified in Part A and B of BOQ are essential in nature and has to be carried out on daily basis and as per the requirement of BHEL. The week offs for these items of work shall be planned as per requirement of BHEL.
2. The item of work as specified in Part C of BOQ is to be carried out on milestone basis. The item of work shall be divided on 12 milestones. The work shall be carried out on monthly basis and as per requirement.
3. The works shall be executed with the directions, instructions, which shall be given to the contractor by BHEL from time to time and as per technical specifications in price schedule and drawings available in the office to give a general idea of the work to be executed and is liable for modifications during the actual execution based on the designs prepared and approved by the Competent authority.
4. If the specifications found wanting relevant technical specifications along with the tender shall be followed. Further missing details relevant CPWD and IS specifications shall be followed. Wherever, there is difference in between CPWD and IS specifications latter shall prevail.
5. For execution of all scheduled items CPWD specifications and relevant IS codes are to be followed. For execution of non-scheduled items specifications enclosed with this tender are to be followed.
6. Specialized works are to be executed by specialized agency with the approval of BHEL.

Engineer in charge shall be final in this matter. If the defective work is allowed to stand BHEL shall have the absolute right to reduce the rates for such items and the contractor shall have no claims over such defective work allowed on reduced rates.
