SCOPE OF WORK

Visiting of Producer Gas Pipe line across the BHEL, RC Puram plant (In & Outside the blocks):

1. Study of Producer gas pipe line (different sizes) located at an elevation of 10m from the ground from Condemned PG Plant to 203 block.
2. Study of producer gas pipe line (different sizes) located at an elevation of 10m inside the production blocks.
3. Submission of valuation report i.e. **Scrap value** of Producer Gas pipe line in **Rupees per ton** considering all the points mentioned here.

Note: Condemnation of Producer gas pipeline work by Scrap contractors also involves cutting of pipe line into small pieces, dislodging them to ground without any damage to side by process lines (Oxygen, Nitrogen and compressed air lines), and taking away from BHEL to outside by taking all safety precautions (by arranging required tools & tackles, skilled manpower and transportation apart from safety considerations).
