2	PENALTY : Penalty clause is applicable in case of delay in execution of work beyond completion period. Rate of penalty applicable is 0.5 % per week or part thereof to a Max of 10% of total contract value.	
3	CONTRACT PERIOD: 30 days.	
3	SECURITY DEPOSIT: Security Deposit should be collected from the successful tenderer. The rate of Security Deposit 5% of the order value. SCOPE OF WORK

Repair/Rewinding of 9.4kW, 110V DC, 1500rpm DC Series Motor.

The scope of work includes shifting of the DC series motor to vendor works. Complete repair, Testing of the motor to be done. Dispatch of the motor to BHEL shall be after PDI (Pre Dispatch Inspection). Repair of the motor includes the following:

- a) Dismantling of the motor.
- b) Rewinding of armature with Class-F insulation.
- c) Commutator skimming, under cutting and cleaning.
- d) Dynamic balancing of Armature shaft.
- e) Servicing of main-field and inter poles coils.
- f) Re-assembly and testing of the repaired motor.
- g) To/from transportation of the motor to vendor works is also in contractor's scope.
- h) Vendor should retain old/scrap materials.
