Financial Terms & Conditions

TAXES & DUTIES:

- 1. To enable BHEL to avail GST Input tax credit, contractor shall submit GST compliant Tax invoice containing all the particulars as stipulated under Invoice Rules of GST Law. Payment shall be made to the contractor only after submission of GST complaint Tax invoice. The successful bidder shall raise GST compliant invoice affixing GSTIN of BHEL's unit availing the services.
- 2. BHEL reserves the right to protect its interest against any loss on account of availability of GST credit.
- 3. GSTIN of BHEL will be provided to the contractor along with the work order.
- **4.** Any new/change in statutory levy as and when made applicable by the Government shall become applicable against documentary evidence.
- **5.** Payment to the contractor will be subjected to TDS as per rules in force from time to time. PAYMENT TERMS:
