WORK SPECIFICATION

SCOPE OF WORK:

LDO is envisaged as secondary fuel to the boiler. For making LDO storage facility, an unloading tank of 20 KL capacity and day oil tank of 5 KL capacity are planned to be established at BHEL Jhansi plant. Consultancy services are required for obtaining one-time approval for storage of total facility complying to PESO norms. Following are the major scope of works for mentioned subject-

CONSULTANCY FOR OBTAINING ONE TIME STORAGE APPROVAL FOR LDO (PETROLEUM CLASS-C):

Constructional Drawing Preparation, getting approval of layout drawings and obtaining of one-time license for storage of Light Diesel Oil (LDO: Petroleum Class-C fuel) at BHEL JHANSI from Statutory Authority Petroleum and Explosives Safety Organisation (PESO) in accordance with Petroleum Act including payment of license/scrutiny fees to PESO.

1. CONSTRUCTIONAL DRAWING PREPARATION:

Preparation of Constructional Drawing including tank storage, enclosure, unloading station, piping etc. for submission to PESO and related government departments. The required Factory Layout Plan and any other required details will be given by BHEL to enable the vendor to complete the drawing as per Petroleum Act.

2. CONSTRUCTIONAL DRAWING APPROVAL & OBTAINING GRANT OF LICENSE FROM CCOE OFFICE:

Following works are in the scope of vendor-

- A. Site visit and collection of all supporting documents, preparation of sanction drawings, drafting and submission of proposal to the concern authority, liaison with local / central authorities for getting NOC/ clearances, answer to the queries raised by the PESO department online and offline as needed and grant of license under Class-C permission for storage of LDO.
- B. Inspection and issue of test certificate under rule 126 and 130 for testing of tank as per Petroleum Act.

3. COMMON FOR ITEM SL. NO. "1" AND "2":

- A. All the activities as detailed in the above-mentioned Scope of work like layout drawing approval, PESO document preparation, online document submission, payment of license /scrutiny fees as applicable, any other activities required as per Petroleum Act which are necessary for layout drawing approval and for obtaining License for storage facility is in the scope of vendor.
- B. The vendor shall quote lumpsum value inclusive of expenditure for layout preparation, depositing\ statutory fees, grant of license, endorsement of license by PESO Inspector, final handover of license to BHEL JHANSI, conveyance etc. No extra charges will be paid for any other expenses incurred for but not included herewith.
