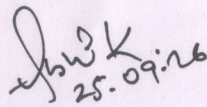

- 3.0 Unless specifically mentioned otherwise in the tender document, the tenderer shall quote for the finished items and shall provide for the complete cost towards supply of materials including consumables, labour & other misc. elements that may be required for carrying out the job including transport, layout, rectification, maintenance till handing over, supervision, overheads, profits etc. including all incidental items complete.
- 4.0 The quantities in this schedule are approximate and may vary to any extent or may be deleted altogether. The rate quoted against each item of the schedule shall remain firm till the contract value remains within "+" or "-" 15%.
- 5.0 The rates shall be quoted both in figures & words in clear legible writing. No overwriting is allowed. 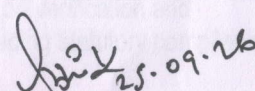

1.2	The Following shall be under the scope of successful Bidder: a) Bidder has to obtain all statutory compliances as required for working at project site. b) Bidder has to maintain at site, suitable number of supervisors, as may be required, for taking care of statutory compliances including payment to workers on regular / monthly basis, etc. c) Bidder has to bear the cost on account of food, cooking & eating utensils etc. for the deployed manpower within the quoted rates d) Bidder has to bring all necessary T&P, etc. e) All safety PPEs shall be provided by the agency within the quoted rates. f) Providing all PPE Kits such as safety helmet, safety shoes, safety jacket, gloves, lifelines, fall arrestor ropes, guy ropes etc.

3.1	Contractor has to mobilize the workers with all necessary T&P at site immediately (withing 2 days) after issuance of the work order. 3.3	Guarantee Period: - NIL
4.0	Contract Duration: It shall be for a period of 30 days. However, if required BHEL at its discretion may extend the contract further as per requirement.
5.0	TERMS OF PAYMENT: A) 100% of the payable amount as applicable, would be released within 30 days on verification and acceptance of the GST invoice subject to its completeness in all respects including statutory compliances, certification by BHEL EIC along with submission of following documents: B) Payment will be released within 30 days of submission of documents as mentioned above. C) Paying Authority: RAO, BHEL Site Office, 1 x 660 MW Unit-V, Sagardighi TPP extension D) No advance shall be paid. Payment shall be made on the basis of actual execution at site.
5.1	PRICE VARIATION CLAUSE / RATE REVISION
	The accepted rates shall remain firm throughout the execution period including extension period, if any, and no escalation / revision shall be payable.
6.0	TAXES & DUTIES, ETC.
6.1	All taxes excluding GST (as specified elsewhere in the tender) but including, Charges, Royalties, any State or Central Levy and other taxes for materials if any obtained for the work and for execution of the contract shall be borne by successful bidder and shall not be payable extra by BHEL. Any increase of above at any stage during execution of contract, including extension of the contract, shall have to be borne by successful bidder contractor. Bidder's quoted/accepted rates/ price shall be inclusive of all such requirements.
6.2	GST (as applicable) legally leviable & payable by successful bidder as per GST Law shall be paid by BHEL, extra. Hence, bidder shall not include GST (as applicable) in their quoted rates/ price.
6.3	Successful bidder shall furnish proof of GST registration with GSTN Portal covering the services under this contract. Registration should also bear endorsement for the premises from where the billing shall be done by successful bidder on BHEL for this project / work.

6.4	Since GST on output will be paid by BHEL separately as enumerated above, bidder's quoted rates / price should be after considering the Input Credit under GST law at bidder's end.
6.5	TDS under Income Tax shall be deducted at prevailing rates on gross invoice value from the running bills (RA bills) unless exemption certificate from the appropriate authority / authorities is furnished.
6.6.1	You may collect TCS under section 206C(1H) of Income Tax Act, 1961 if applicable.
6.6.2	You shall comply with all statutory amendment/notifications in this respect
6.7	TDS under GST shall be deducted at applicable rates on gross invoice value from the running bills (RA bills).

6.9	In case of raising any Supplementary Tax Invoice (Debit / Credit Note), successful bidder shall issue the same containing all the details as referred to in Section 34 read with Section 31 of GST Act & Rules referred there under
6.10	Successful bidder shall comply with the Time Limit prescribed under the GST Law and rules thereof for raising of the Tax Invoice. If any supply of goods is applicable, successful bidder shall also ensure prompt delivery of goods after dispatch.
6.11	Bidder shall note that in case GST credit is delayed / denied to BHEL due to delayed / non receipt of goods and / or Tax Invoice or expiry of the timeline prescribed in GST Law for availing such ITC, or any other reasons, not attributable to BHEL, GST amount shall be recoverable from successful bidder along with interest levied/ leviable on BHEL, as the case may be
6.12	Successful bidder shall upload the invoices raised on BHEL in GSTR-1 within the prescribed time as given in the GST Act. Bidder shall note that in case of delay in declaring such invoice in your return and GST credit availed by BHEL is denied or reversed subsequently as per GST Law, GST amount paid by BHEL towards such ITC reversal as per GST law shall be recoverable from the successful bidder along with interest levied / leviable on BHEL.
6.13	Any new taxes & duties, if imposed subsequent to due date of offer submission as per NIT & TCN, by statutory authority during contract period (including extension, if the same is not attributable to you), shall be reimbursed by BHEL on production of relevant supporting document to the satisfaction of BHEL. However, you shall obtain prior approval from BHEL before depositing new taxes and duties
6.14	Benefits and / or abolition of existing taxes must be passed on to BHEL against new taxes, if any, proposed to be introduced at a later date.
7.0	<u>SUITABILITY / ASSESSMENT OF QUALITY AND COMPETENCE OF LABOURS:</u> BHEL reserves the right to check the ability and experience of the workers prior to engagement. BHEL will reserve the right to check the health condition of the worker in Safety Park by a team of medical expert and Safety engineer as per the BHEL safety norms based on type / nature of works and in case of rejection, the demobilizing of the workmen shall be at the cost of successful bidder.
8.0	<u>TERMINATION OF CONTRACT:</u> If at any time during the execution of the order, it is noted that the contractor is not discharging his obligations according to the terms of this contract, then BHEL will be at liberty to terminate the contract after giving 7 days' notice by issuing contractual letter and the tenderer shall comply with the requirement of such notice. In such case no payment will be given for the balance work of contract including unsatisfactory services, if any.
9.0	<u>LIQUIDATED DAMAGE (LD):</u> It is to be clearly understood that the scope of work as specified in the work order should be made within the time limit as prescribed by BHEL. If the contractor fails to maintain the required progress of work which results in delay in the completion of the work as per the contractual completion period, BHEL shall have the right to impose Liquidated Damage/Penalty at the rate of 0.5% of the contract value, per week of delay or part thereof subject to a maximum of 10% of the contract value.
10.0	<u>OTHER TERMS & CONDITIONS</u>
10.1	The successful bidder has to abide by all the rules of SGTPP site including HSE plan related rules.

10.2	The representative of the vendor should be available as per requirement at SGTPP Site for continuous supervision of the workmen as per the productivity, safety and quality norms of the BHEL standard.
10.3	Contractor shall ensure that no IR issues or problem is created at site and if any such issue is created at site, then BHEL reserves the right to immediately terminate the contract. Contractor shall obtain undertaking from each worker in this line before mobilization of any such worker to site.
10.4	BHEL reserve the right to cancel the order in case of delay in mobilization of workmen by successful bidder and failure to comply with quality, HSE and productivity requirements.
10.5	The Contractor shall be responsible for safety of his workmen, materials and equipment deployed at site.
10.6	Refreshment and drinking water for the workmen, has be arranged by the contractor.
10.7	All labour rules, factories act, statutory requirements to be strictly adhered by the contractor.
10.8	Sub-letting of jobs within the agreed scope of work, in any way is not permitted.

The quantities of job in this schedule are approximate and may vary to any extent (upward / downward) or may be deleted altogether. The rate quoted against each item of the schedule shall remain firm till the contract value remains within "+" or "-"15%.
10.12	Contractor's personnel posted at site shall not move outstation without the prior permission of Construction Manager of BHEL.

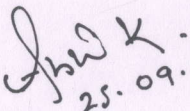
