Part-I: Techno commercial bid

External services Hydro, BHEL, Bhopal invites sealed quotations for hiring vehicle during Rectification / refurbishment and COH work of Unit#1 at Tons HPS, sirmour, (MP).

Terms & Conditions

- 1. Reporting place for the vehicle shall be at MPPGCL guest House, Sirmour, Rewa MP.
- 2. Normal working hour shall be 12 Hrs for all days of the month. Depending upon the requirement the working hours may be from 08:00 AM to 08:00 PM.
- 3. The vehicle shall be used for visiting places in & around Tons power house, such as sirmour, Rewa (MP)/ Dabhora, bus stand/ railway station, market or local travelling to nearby town as per the instructions of Site In charge. No extra charges shall be paid over and above referred rates by the company. However, Parking and Toll charges will be borne by BHEL, for which actual receipts are to be submitted.
- 4. Vehicle shall be 7 seater like Mahindra Xylo, Tavera, Bolero and Scorpio or equivalent with operational AC, registered as Taxi after 1st September 2015. It should be in very good running condition with necessary seating comforts. Work order may be cancelled immediately if BHEL site in charge does not find vehicle in adequately good running condition & comforts.
- 5. Vehicle bidder shall quote rates including fuel charges, OT charges etc in the attached Annexure "V". Bidder may quote for more than one vehicle type separately.
- 6. Fuel cash memos with details and logbook shall be maintained by the contractor for record of actual fuel consumption / running of vehicle.
- 7. Logbook shall be signed on daily running basis.
- 8. The vehicle bidder shall provide a licensed driver with mobile phone, neat & clean dress and should complete all legal formalities. He should be physically fit. vehicle provided should be thoroughly washed and cleaned.
- 9. In case if vehicle is off road for minor / major maintenance, alternate vehicle is to be provided by bidder. In case of noncompliance of the same the vehicle shall be hired from market at risk and cost of bidder.

- 10. The bidder shall provide additional vehicle if asked by BHEL on the same rate as per annexure-V and terms & conditions as per annexure-I.
- 11. The payment shall be made within 60 days after end of the work through NEFT/ Cheque after deduction of income tax/GST at the prevailing rates. Any new taxes, duties, levies if imposed by the Govt. after submission of quotation shall be paid extra by BHEL.
- 12. NEFT details are to be submitted by the successful bidder within one week on placement of order.
- 13. The bidder shall provide electronic Fund Transfer (EFT/RT/RTGS) Details, PAN details, service tax/ in bidder profile details (refer annexure-II).
- 14. GST registration number if applicable shall be provided in bidder profile details by vehicle bidder to BHEL (refer annexure-II). Statutory deductions will be applicable as per law.
- 15. The driver shall be required to keep valid driving license, vehicle registration, and comprehensive insurance including that of driver, road permit & other necessary documents as per relevant acts applicable as per vehicle act of the state.
- 16. Any fine levied on vehicle or driver because of not following any Central/State Government rules will be borne by vehicle bidder.
- 17. The bidder shall submit details of valid driving license, vehicle registration, and comprehensive insurance including that of driver, road permit & other necessary documents as per relevant acts applicable as per vehicle act of the state in bidder statement of vehicle in attached annexure-III of qualifying criteria of bidder.
- 18. The driver should have sufficient cash to pay for any toll tax / parking charges / entry tax as and when required and also should be in position to pay for any minor repairs necessitated due to sudden breakdown of the vehicle on the road.
- 19. In no case, money should be borrowed by driver from the occupant of the taxi. Any payment to driver including his food and incidental shall be borne by contractor.
- 20. Payment for vehicle running, duty in excess of 12 hrs / day and night halts at outstation shall be paid extra. Night halt & overtime will not be paid simultaneously. In case of outstation duty, only night halt will be paid extra.
- 21. Consumption of drugs/alcohol by driver during duty time is strictly prohibited.
- 22. The service of vehicle can be discontinued by either side on giving 7 days' notice & balance payment will be released on pro rata basis.
- 23. Vehicle service can be made on hold by BHEL site in charge temporarily on giving prior notice of 2 days with a relevant reason of held up of site operation. During that period, only hire charges will be paid on pro rata basis and vehicle service again can be restored on notice period of 2 days.
