**Read:** Rates of Optional Items (each item of Ann-II of MENU/SCOPE) under Catering services are to be quoted in Ann-II of Price Schedule in terms of percentage of prevailing MRP for Items in Sl. No. 3 only. Rates of Item No. 1 & 2 have to be reasonable and consistent compared to each other and in relation to that as mentioned in Ann-IA.
