Qualifying criteria - Pre-Qualification Requirement (PQR)

Pre-Qualification Requirements (PQR) for Multimedia cleaning device:

Intending firms / Vendors shall comply and fulfill the criteria of satisfactory execution of similar products as given below as minimum requirements:

Vendors who satisfy the following criteria can only quote.

Pre-qualification requirement (PQR) for Multimedia Cleaning device

The bidder has to meet the provenness criteria for Multimedia cleaning device for Air preheater application as stipulated below.

A) The Bidder should have already designed, manufactured and supplied "Retractable type multimedia cleaning device with Control system" for Air Preheater application to BHEL, Ranipet.

OR

The Bidder should have previously designed, manufactured and supplied "Retractable type multimedia cleaning device with Control system" for Air Preheater application in a Boiler or Gas to Gas heater application in a Flue Gas Desulfurization system. The device should be capable of cleaning the heating elements using High pressure water & Steam.

The device should have been designed for operating not less than 200 Kg/cm²(g) for Water and 12 Kg/cm²(g) at 300 deg C for Steam. It shall be in successful operation in at least one (1) plant for a period of not less than one (1) year on the date of techno-commercial bid opening.

Bidder shall furnish the Supply list for Multimedia cleaning device indicating Customer name, Project, Country, cleaning device Model number, Quantity, Application, Date of supply & Date of Commissioning.

The following information should be submitted by the Bidder where the Multimedia cleaning device has been supplied and working for not less than One year:

- a. Name of the customer & Project details where the Cleaning device is supplied.
- b. Water pressure & Steam pressure for which the device is designed for
- c. Complete postal address of the customer.
- d. Name, designation and contact details of the contact person of the customer.
- e. Month & Year of commissioning.
- f. Relevant un-priced Purchase Order copies

B. Minimum average annual Turnover shall be INR 53 Lakh (Supplier to furnish Last three years Balance Sheet.

C. BHEL reserves the right to verify the information (supporting documents for points a to f) and other credentials provided by the Bidder. In case the information provided by Bidder is found to be false / incorrect, the offer shall not be considered.
