- 2. **Type of BID**: Two Parts BID. Offer should be submitted in TWO parts. As per the following:

2. PRICE BID IN A SEALED ENVELOPE AND SUPERSCRIBING

Price: The offer should clearly indicate unit rate per piece. Price should be submitted on - SUPPLY: FOR BHEL R & D HYDERABAD. I & C and O &M are at site. This will be firm price contract and no claims will be entertained on this account after acceptance of the tender or during the currency of the contract. The rate quoted in the tender shall remain valid for a period of six months from date of opening of the tender.

- 5. **Delivery schedule**: The PCU system is to be supplied, installed and commissioned within 10 weeks from the date of Purchase Order.
- 6. **Payment terms**: Our standard payment term is as below: Supply: 90% on receipt at BHEL R & D Hyderabad. Balance 10% after installation and commissioning. I & C: 100% after Installation and commissioning against BG for 10% of supply value. BG to be valid till the end of the guarantee period.
- 7. **Guarante/Waranty:** As per Purchase specification PS-439-017. 24 months from the date of commissioning.
- 8. **Pre-Inspection:** BHEL reserves the right to inspect the material at supplier works before despatch as per specifications.
- 9. **Tender Evaluation:** Evaluation of the Tender shall be for the total value of supply, I & C and O & M.

- 11. **Licenses:** All export formalities including license, Government permissions or any other statutory clearance from their country of export as per regulations existing in the supplier's country shall be the responsibility of supplier.

- 20. Conditional and un witnessed tenders, tenders containing absurd rates and amount, tender which are incomplete or otherwise considered defective and tenders which are not in accordance with tender conditions laid down by the accepting officer are liable for rejection.
