2	Bidder shall submit requisite Documentary evidence such as, a) Purchase order copy indicating the project for which order was undertaken, Order value, Scope of work, Contact details of order placement agency b) Customer/Consultant Approved Datasheets / Drgs/ QAP c) Inspection reports (routine/type/acceptance) witnessed by third party/customer d) Despatch clearance e) Supply Completion certificate from order placement agency OR Bidder certified list of invoices raised to order placement agency indicating major supply completion details Bidder shall submit details of experience, i.e., jobs executed, jobs in progress in the FORMAT indicated below, along with the offer. 2	Audited annual report (balance sheet and profit & loss account), ITCC/ITR for the financial years 2016-17, 2017-18 & 2018-19 needs to be submitted in support of above mentioned financial requirement.
