4	<p>Supplier to confirm/provide the following criteria/documents for evaluation of offer.</p> <p>I. Vendor should have manufactured and supplied Dished ends with ID ranging from 800mm - 2300mm and with a plate thickness up to 16 mm from the proposed manufacturing plant. Particulars of experience / credentials of the orders which are executed of similar nature not older than 3 years (PO copies, Quality plans, test reports of the orders to be enclosed).</p> <p>II. Vendor should confirm complete compliance to BHEL drawing no 35601001041 . If any deviation with respect to drawing, vendor has to provide the deviation list for BHEL review.</p> <p>III. The offers of the bidders who are on the banned list and also the offer of the bidders, who engage the services of the banned firm shall be rejected. The list of banned firms is available on BHEL website "www.bhel.com".</p>	

	IV. All the documents shall be furnished only in English. Documents furnished in other languages will not be considered for further evaluation.	
5	Offers without the requirement as above 4(I),4(II),4(III),4(IV) will not be technically evaluated by BHEL. Further, no correspondence in this matter will be entertained.	
6	BHEL team may carry out vendor evaluation/assessment (incase of a new vendor) by a visit to vendor works for qualifying /rejecting the technical bid based on the findings of the visit.	
7	<p>I. The minimum average annual financial turnover of the supplier during the last 3 financial should be more than Rs. 3 Lakhs (In Words, Three Lakhs Only) and positive net worth as per latest balance sheet.</p> <p>II. Vendors shall enclose the last three financial years balance sheets and Profit & loss statements duly audited and certified by Chartered Accountant.</p> <p>III. In case of final audited balance sheet / Profit & Loss statement for the last year is not available, provisional statement for the same duly certified by Chartered Accountant must be submitted.</p> <p>IV. In case audited financial statements have not been submitted for any of three years as indicated above, then the applicable audited statements submitted by bidders against the requisite three years will be averaged for three years i.e total divided by three.</p> <p>V. Other incomes shall not be considered for arriving at annual financial turnover / sales. For evaluation purpose, only revenue from operations shall be considered.</p>
