1.	<p>The bidder is required to meet the provenness criteria and / or qualification requirement for Lime Feeding / Dosing system as per criteria stipulated below:</p> <p>“Bidder should have engineered / got engineered, supplied, erected / got erected at least one (1) number bulk material handling plant (essentially comprising of material handling/ conveying using bucket elevator/ bucket conveyor of minimum 1 T/hr rated capacity or above, for lime or other material, which is in successful operation for a period of not less than one (1) year as on date of bid opening”.</p>
2.	<p>The supplier has to submit following supporting documents meeting above mentioned pre-qualifying requirement:</p> <p>Copy of minimum one (1) performance certificate (in English) from end user along with copy of related Purchase Order (PO) or Letter of intent (LOI) or Letter of Award (LOA) or Work Order (WO), specifying that the product is running successfully for at least one (1) year from date of commissioning, in support of PQR clause mentioned at sr. no.- 1 above.</p>
3.	<p>Bidder shall submit design documents to substantiate technical parameters specified in PQR, if the same is not mentioned in performance certificate / purchase order / LOI / LOA / WO.</p>
4.	<p>Offers of the JV companies/ Joint Bidders/ bidders having collaboration/ licensing agreement/ MOU/ Indian subsidiaries shall also be acceptable (the same shall be <b>declared upfront during the bid submission</b>) and shall be evaluated as follows:</p> <p>a. If bidder happens to be an Indian subsidiary of foreign OEM, then the credentials of the foreign OEM can also be considered for meeting PQR.</p> <p>b. If bidder happens to be the Joint Venture Company, then the credentials of any of JV partners can be also considered for meeting PQR.</p> <p>c. If bidder happens to bid jointly with their partner, then credentials of both the partners will be considered for meeting PQR as per distribution of the work. In all such cases, lead bidder as specified in bid documents shall be responsible for overall execution of the contract and all guarantee/ warranty.</p> <p>d. If bidder happens to be the having valid collaboration agreement/ MOU/ licensing agreement with some other company, then the credentials of collaborator/ MOU partner/ licensing company can also be considered for meeting PQR.</p> <p>Note: If bidder(s) qualifies on the basis of credentials of his principal/ JV partner/ Collaborator/ joint bidder etc., then the principal/ JV partner/ Collaborator/ MOU partner/ joint bidder shall be responsible for overall design vetting and warranty/ guarantee of the package. The scope matrix clearly defining their respective roles including design vetting, manufacturing of critical component, E&amp;C etc. etc. and warranty/ guarantee shall be submitted along with the offer. Also, to note that the arrangement of bidding (Joint Bid Partners/Collaborator/MOU partner/Licensing company etc.) once offered to BHEL as a part of bidding documents cannot be changed till the execution of the project.</p>
5.	<p>Minimum one (1) no. purchase order/ LOI / LOA / WO shall be submitted which should not be more than seven (7) years old as on date of bid submission, for establishing continuity in business. This is over and above the requirement of PO mentioned of PQR clause at S. No 2 above.</p>
6.	<p>Bidder to submit all supporting documents in English. If documents submitted by bidder are in language other than English, a translation of its pertinent passages in English language in which case, for purposes of interpretation of the bid, the translation shall govern. The English Translation of the documents shall be carried out by professional translators and the translator shall certify that he is proficient in both languages in order to translate the document and that the translation is complete and accurate. Further, translation shall be authenticated by the Indian Consulate located in the Country where the documents have been issued or the Embassy of that Country in India.</p>
7.	<p>Notwithstanding anything stated above, BHEL/ NTPC reserves the right to assess the capabilities and capacity of the bidder to perform the contract, should the circumstances warrant such assessment in the overall interest of BHEL/NTPC.</p>
8.	<p>Consideration of offer shall be subject to customer’s approval of the bidder.</p>
9.	<p>After satisfactory fulfilment of all the above criteria/ requirement, offer shall be considered for further evaluation as per NIT and all the other terms of the tender.</p>
