1)	<p><b>TECHNICAL PQ CRITERIA</b></p> <p>Bidder should have experience of having successfully completed * Electrical Erection and Commissioning works covering (not necessarily in single job) similar to the BOQ of this tender such as Erection &amp; testing of MCC Panels/PLC panels/Local Control panels/Distribution boards, Power/Control /Instrumentation cable/OFC cable laying and termination , Field Instruments, Cable tray &amp; supports erection works for Power Plants/ Industrial Plants or any other industrial units or Electricity boards <b>during last 7 (seven) years ending 30-Apr-21</b>, in any one of the following (excluding taxes) :</p> <p>a) Three similar completed works each costing not less than <b>Rs. 31 Lakhs</b> or b) Two similar completed works each costing not less than <b>Rs. 39 Lakhs</b> or c) One similar completed works each costing not less than <b>Rs. 62 Lakhs</b></p> <p>* Successfully completed in India only. Note: Consortium or Joint ventures are not allowed.</p>
2)	<p><b>FINANCIAL PQ CRITERIA:</b></p> <p>Audited average annual financial turnover during the last 3 years, ending 31st March 2020, should be atleast <b>25 lakhs</b> per annum. Annual reports like Audited financial statements (balance sheet &amp; Profit &amp; loss account) of these three years shall be submitted in support of the above requirement. Other income shall not be considered for arriving at Average Annual Turnover/ Sales.</p>
