

## **ANNEXURE-A**

**(All the terms and conditions mentioned below are to be accepted by vendor)**

1. The sizes of Formal wear Blazer are tentative and they will be finalized at the time of placement of final purchase order. However, the total quantity shall remain same i.e. 941 nos. The tentative requirement of Formal wear Blazer for men's & women's both with the corresponding are as following: -

2. **Pre-Qualifying Requirement:** Bidder shall have experience for supply of bulk order to GOVT./PSU/PRIVATE SECTOR with at least execution of one order having value more than Rs. 3.00 Lacs during last five years from the date of tender opening (Part-I Technical Bid). The bidder has to submit the copy of their purchase order along with quotation as proof.

It is to be noted that failing to meet the Pre- Qualifying Requirement (PQR) shall lead to rejection of offer.

3. Sample of atleast 01 No. of Blazer is required to be submitted by those vendors only, who shall meet the attached technical specification no. BHE/JHS/WLF/Blazer/01 as well as Pre-Qualifying Requirement (PQR).

4. The bidder may submit 3-4 different types of formal wear Blazer samples as per above specification.

5. The sample shall be evaluated in consultation with recognized Trade Unions for their acceptance. Price bids of only those offers will be opened who are Techno Commercially acceptable, meeting pre-Qualifying Requirement and their sample is acceptable.

6. The received samples will be approved by BHEL, Jhansi and there may be minor modifications in the sample at the time of approval and the modifications shall be including in the purchase order.

7. Vendor to collect his samples from BHEL at their own cost within 2 weeks from the date of intimation.

8. Sample of all sizes (mentioned at SI No. 03) to be submitted by the successful bidder within 7-10 days from the date of price bid opening. This is required to arrive the exact size wise quantity. However, it is to be noted that total quantity shall remain as 941 nos.

9. Vendor has to replace the rejected quantity at his own Risk & cost within 1-2 weeks from the date of intimation from BHEL, Jhansi.

10. Bidder shall be either original manufacturer of the tendered item or their duly authorized distributors. In case if offer is received from both manufacturer and their authorized distributor/dealer, offer of manufacturer shall be considered only for price bid opening.

11. **Inspection:** - Final Inspection will also be carried out at our works with reference to the approved sample along with Technical specification BHE/JHS/WLF/Blazer/01 and test report submitted along with supply and as per purchase order. BHEL Jhansi may inspect at manufacturer's work at its discretion with reference to the approved sample and technical parameters with reference to BHE/JHS/WLF/Blazer/01. The supplier shall give inspection call 3 weeks before dispatch of material. BHEL will depute its representative within 10 days from the date of intimation or date of offered inspection, whichever is later.
