### SPECIFICATION FOR PHOTO RESIST SPINNER

### TECHNICAL DESCPRIPTION AND SPECIFICATIONS

#### **GENERAL DESCRIPTION**

The photo resist spinner shall be used for coating silicon wafers of varying diameters (19 mm to 150 mm) with approximately 1 micron of Positive / Negative photo resist with a viscosity of around 180 CP. The spinner shall be provided with a vacuum chuck to hold silicon substrates. The equipment shall be provided with a lid for safety and an automatic resist dispensing system. The equipment shall have provisions for setting the various parameters like time and speeds (Typical Speeds 6000 rpm) under vacuum.

It shall be provided with a programming unit which can be programmed, to carry out dispensing , coating, spinning at two speeds and stop the spinning on completion of process . The substrate will be lifted from the vacuum chuck after releasing the vacuum manually. The extra photo resist available in the bowl shall flow out to a collecting tray / disposable container for discarding. Solvents like Acetone / Toluene will be used to clean the bowl.

The system shall comprise of a solvent resistant casing and bowl. The electronic controller shall be accessible freely for changing the set parameters. The display shall be LCD / LED based.
