1. TECHNICAL PQ CRITERIA

Bidder should have experience of having successfully completed* similar works** during last 7 years as on 30.09.2024 and should be either of the following (excluding taxes):

A	3 Nos similar completed works each not less than Rs 292 Lakhs (OR)
B	2 Nos similar completed works each not less than Rs 365 Lakhs (OR)
C	1 No. similar completed work not less than Rs 584 Lakhs

* Successfully completed in India by the bidder only (Consortium or Joint ventures are not allowed). The bidder should have achieved the criteria specified above even if the complete contract has not been closed.

** Similar works:

Electrical Erection and Commissioning works covering (not necessarily in single job) similar to the BOQ of this tender such as MCC Panels/bus ducts/transformers/distribution boards, DCS/ VMS panels, Earthing, Power/Control /Instrumentation cable laying and termination, Cable tray & supports erection works for Power Plants/ Process Industry/ Electricity boards.

2. FINANCIAL PQ CRITERIA:

Audited average annual financial turnover during the last 3 years (2021-22, 2022-23, 2023-24), should be at least **219 lakhs** per annum.
