


## **PRE-QUALIFICATION REQUIREMENT (PQR)**


### **TENDER ENQUIRY NO.: “FRAMEWORK AGREEMENT FOR SUPPLY OF GALVANISED STEEL SUPPORT STRUCTURE”**

The BIDDER has to compulsorily meet all the following pre-qualification requirement to get qualified for further evaluation of their BID in the above Open Tender Enquiry.

<b>S. No.</b>	<b>Pre-Qualifying Criteria</b>	<b>Documents required from Bidder</b>
i)	The BIDDER should have manufactured and supplied a minimum of 150 MT G.I. support structure/similar items (galvanized steel structure/trays/lattice/gantry structure/PV module mounting structure etc.) in the previous year (2024-25) or 300 MT in the past two (02) years (FY- 2023-24 & 2024-25).	BIDDER to submit copy of GST challan and related PO copy/ customer certificate
ii)	BIDDER should have a minimum monthly manufacturing capacity of 50 MT of G.I. support structure.	BIDDER to submit Self - Declaration on letter head, standard quality plan and list of plant and machinery
iii)	BIDDER should have in-house hot dip Galvanizing facility suitable for up to 06 meter job or tie-up with third party for galvanizing of up to 6 meter job.	BIDDER to submit self -Declaration on letter head or proof of tie-up.
iv)	BIDDER should be ISO 9001 compatible organization with valid certificates on tender submission date.	BIDDER to submit copy of certificates.
v)	BIDDER must not be under category “banned” or “de-barred from dealing” by BHEL/PSUs/ Govt. of India on tender due date/time.	BIDDER to submit self -Declaration on letter head.
vi)	Average annual Turnover of the BIDDER in last three years must at least be Rs. 1.3 crore. Net worth of BIDDER (from the audited figures) should be positive in last three years.	BIDDER to submit copy of audited balance sheet.
vii)	BIDDER should have supplied directly or through a main contractor or should be registered/approved supplier to any of the following public sector entities/ power utilities: M/s. BHEL, NTPC, NHPC, NPCIL, SEBs, PGCIL, BSNL/MTNL, Indian Railways/DMRC, Govt. owned infrastructure construction companies /deptt. etc.	BIDDER to submit proof of supply/copy of approval or registration.
viii)	Integrity Pact (format available with the tender documents)	BIDDER to submit signed and stamped copy.

BHEL reserves the right to verify the information provided by the BIDDER. In case the information provided by vendor is found to be false/incorrect at any stage (during tender or after tender stage), the offer shall be summarily rejected.
