Important Notes:

- 1) Scope of Work shall be as per Technical Conditions of Contract attached as part of NIT.
- 2) Bidder shall quote total **Lumpsum Price as mentioned in table above** for both providing process License and Engineering services During Pre-Bid Engineering and Post-Order Engineering.
- 3) Engineering Sub-Contractor (ESC) shall be finalized basis Overall L1 on the total Lumpsum price (C) quoted by the bidders above.
- 4) ESC will be paid max of 3.5% of (C) above towards Pre-Bid Services (Engg + Licensing) rendered and balance will be considered for Post-Order services (Engg + Licensing).
- 5) Two Separate Work Orders shall be placed by BHEL on the ESC, one during Pre-Bid Engineering (immediately after finalization of LESC) and another for Post-Order Engineering. Work Order for Post-Order Engineering will be placed only in case of BHEL winning the Contract from End Customer IOCL. ESC shall not have any claim whatsoever on the Post-Order Engineering component, if BHEL is not successful in winning the Contract.
- 6) Bidder to submit Unpriced Price Bid with "Quoted" above along with the techno-commercial bid.

- 7) The Lumpsum price quoted, shall be inclusive of all costs that are envisaged to be incurred by the bidder in connection with the activities that are to be carried out to deliver the Process Licensing, Residual Process Engineering and Detailed Engineering as per NIT including necessary travel charges, Posting at site etc.
- 8) The Lumpsum price quoted, shall be exclusive of GST but inclusive of all other taxes, including any cess or surcharge or levy/tax by whatever name called, imposed under GST law or any other law at any time, for which input credit is not available to BHEL under any interpretation of the law.
- 9) GST at the applicable rates shall be payable extra. However, the same shall not be paid if the input credit thereof is not available to BHEL due to any reason attributable to ESC.
