Notes:

- 1) Scope of Work shall be as per Technical Conditions of Contract attached as part of NIT.
- Bidder to quote in foreign currency, which will be converted into INR at exchange rate as on Technical Bid Opening Date, for evaluation.
- 3) Bidder to quote for item wise prices for License(A) and Engg Sub Contracting(B) separately.
- 4) In case any Bidder quotes only for License, his price will be loaded for evaluation, by INR 40,00,00,000/- for (B)1 and (B)-2 together, Engg Sub Contracting which will be arranged by BHEL separately.
- 5) In case Bidder intends to offer Pre-Bid Engg-for License free of cost, Bidder may indicate 'zero' in (A) 1. The price for Pre-Bid Engg- for Licence may be included in the Post order(A) 2 which would be charged in case of receipt of order by BHEL,
- 6) Licenser & Engineering Sub-Contractor (LESC) shall be finalized on Overall L1 basis on the total Lumpsum price (A) and (B) together quoted by the bidders above.
- 7) Two Separate Work Orders shall be placed by BHEL on the LESC, one for Pre-Bid Engineering (immediately after finalization of LESC) and another for Post-Order Engineering, which will be placed only in case of BHEL winning the Contract from End Customer IOCL. LESC shall not have any claim whatsoever on the Post-Order Engineering component, if BHEL is not successful in winning the Contract.
- 8) The Lumpsum price quoted, shall be inclusive of all costs that are envisaged to be incurred by the bidder in connection with the activities that are to be carried out to deliver the BEDP, Residual Process Engineering and Detailed Engineering as per NIT including necessary travel charges, posting at site etc.
- 9) The bidder quoting for License shall indicate in a separate Annexure to this format, the CAPEX cost of any proprietary equipment needed for his process & OPEX cost of consumables needed along with their unit rates and quantities. The totaling amount in Annexure has to be indicated in (A) 2 above separately, other than License Fee which will be considered by BHEL in evaluation of lowest price for License.
- 10) Bidder to submit Unpriced Price Bid indicating "Quoted" against each item along with the techno-commercial bid. Also Bidder to provide Unpriced Annexure indicating "Quoted" against CAPEX cost of any proprietary equipment needed for his process & OPEX cost of consumables.
- 11) The Lumpsum price quoted, shall be exclusive of GST but inclusive of all other taxes, including any cess or surcharge or levy/tax by whatever name called, imposed under GST law or any other law at any time, for which input credit is not available to BHEL under any interpretation of the law.
- 12) GST at the applicable rates shall be payable extra. However, the same shall not be paid if the input credit thereof is not available to BHEL due to any reason attributable to ESC.

 In case of foreign bidders IGST will be paid by BHEL as reveres charges.
