3 Penalty:

- 4 The contract is for periodic inspection, servicing & maintenance of diesel engine, alternator and AMF panel.
- 5 General inspection & services in a year at equally spaced intervals (not exceeding one month) shall be carried out.
- 6 Oil servicing shall be carried out once in a year or whenever required at the discretion of BHEL.
- 7 AMC shall cover minor breakdowns, valve settings, belt tensioning, general check-ups, checking oil level and radiator water level with coolant additive etc.
- 8 Consumables such as coolant, engine oil etc. and required spare parts for engine, alternator & AMF panel will be paid extra on submission of original invoice / cash bill or will be made available by BHEL.
- 9 The scope of work excludes reconditioning of engine, cutting/welding, machining, radiator works, overhauling/rewinding of alternator.
- 10 No limits on breakdown visit. Breakdown calls if any must be attended within 24 hrs.
- 11 Consumables like diesel, kerosene, Grease, cotton waste etc. will be supplied by BHEL or else will be supplied by the contractor for which separate payment will be made on submission of original Invoice.
- 12 All necessary tools & instruments should be arranged by the contractor.
