Penalty amount so determined along with GST if applicable thereon shall be recovered.</p> <p>b) If the contractor fails to deposit the required security deposit or commence the work within the period as per LOI/Contract, the agency will automatically be suspended from being eligible for bidding in any contract with BHEL for a period of two years from the date of notification.</p> <p>c) If the agency fails to commence the work as requested by the department penalty of 0.5% on the gross value of work for weeks delay will be applicable. 9	The agency has to pay the minimum wages to workers with statutory payments like ESI, PF etc., is as per BHEL notification and as per NIT. For USW= ₹ 550.38, SSW= ₹ 587.73, SW = ₹ 623.54 + ESI + PF + PPE's and other statutory if any increase in future DA is to be borne by the agency.

19	Vendor to ensure correct applicability of IGST/CGST/SGST/UTGST based on the Inter /Intra state movement Supply of goods and services or both.
