Subject: Open tender proposal for inviting bids through "Custom Bid" option on GeM Portal for procurement of 'FREE CUTTING BRASS ROUND Dia 125 MM- 122 Kg' against requirement of indent no. 2024-3598 Rev. 00 (PMD- TG012).

Fresh indent no. 2024-3598 Rev. 00 (PMD- TG012) has been received from MCX- EM (Refer- [TOC Page No. 1-2](#)).

GeMAR & PTS of indented item for indent no. 2024-3598 Rev. 00 (PMD- TG012) on GeM portal and undertaking for custom bid creation as provided by MCX- EM, are placed at [TOC Page No. 5](#) and [TOC Page No. 6](#) respectively. Hence, Custom based bid through GeM portal shall be issued in this case in line with indented requirement/PQR & Quality requirements.

As per [SS&P circular no. 35 of 2022-23](#) the NITs shall be published on the GeM portal by utilizing the "Custom Bid" feature, irrespective of the case value'.

In view of the above, open tender is proposed for inviting bids through 'Custom based bid' on GeM Portal against the requirement of indent no. 2024-3598 Rev. 00 (PMD- TG012), enquiry based on QAX remarks (Refer- [TOC Page No. 1-2](#)) and PQR provided by MTE/EME (Refer- [TOC Page No. 3](#)) while considering the following:

- **Case value** is up to **Rs. 02 Lac** since indent no. 2024-3598 Rev. 00 (PMD- TG012) is of 'A' category.
- [Make in India order dated 19.07.2024](#) and subsequent orders shall be exempted for this tender, as the estimated case value is up to Rs. 02 Lac.
- Tender is proposed to be floated in two parts (Part-1 & Part-2).
- Part-1 (Techno- commercial bid) comprises of Pre-Qualification requirement, NDA (Signed & Stamped- for availing specification and drawing documents to unregistered PMD Vendors/Bidders), Techno-commercial bid along with respective tender documents.
- Part-2 comprises of Price Bid only. Part-2 bid will be opened at a later date, only of those vendors who have qualified PQR, technical scrutiny and Quality requirements.
- PQR, Quality requirements and NDA (for availing specification and drawing documents to unregistered PMD Vendors/Bidders) & respective enquiry documents / formats shall also be uploaded on GeM portal for participating vendors.
- Quantity tolerance of +/-5% shall be applicable on weight (as mentioned in indent) and material shall be procured in length of 230 MM or its multiple (PI refer [TOC Page No. 17](#)).
- EMD/PS is 'Not Mandatory' as the case value is up to Rs. 02 Lacs which in line with [circular no. 13 of 2023-24 dated 29.09.2023 from Corporate SS & P \(Amendment no. 4 PP 2013\)](#).
- MSE benefits as per MSME act stated in GeM (such as Price preference, Payment preference etc.), will be given only to those MSE Vendors who are manufacturers of offered items against the NIT. No MSE benefits shall be provided to Agents / Stockists / Dealers / Traders etc. for the items offered but not manufactured by themselves.
- PMD vendors/LPP vendor (details at [TOC Page No. 7-10](#)) & potential vendors shall be

informed / intimated through e-mail for submission of offers in two parts along with all required documents as asked in NIT on GeM portal and bid shall be published on all known sources.

- Price bid to 'RA' shall be conducted for only those bidders who qualifies PQR and whose techno-commercial bid is acceptable to BHEL. Item wise evaluation shall be done on item wise total landed cost to BHEL basis; RA shall be conducted on GeM portal with available option of '**Bid to RA with H-1 elimination rule**' as per [SS&P Circular No. 08 of 2024-25 - RA Guidelines 2024 \(point no. 2\)](#).
- Considering the GeM as e- procurement as per clause no(s). 8.2 (PP 2013) and 2.18 (PWI); GeM enquiry part- 1 opening date shall be 10 days from enquiry issuing date.

PRICE VARIATION CLAUSE (PVC):

PVC for Price Comparison:

- a. Vendors to quote their total rates in INR for per KG i.e. '[BME Copper Billet Prices and BME H.G. Zinc prices (IN THE RATIO OF COPPER AS 57.5% AND ZINC AS 42.5%) + Fabrication price (which are inclusive of Freight charges, P&F charges (if any))] + Applicable inclusive GST'.

Vendor(s) will take Brass Metal rate (IN THE RATIO OF BME COPPER AS 57.5% AND BME ZINC AS 42.5%) i.e.

Rs. 612.722 / Kg. Vendor(s), who do not confirm this clause, their offer will be rejected.

- b. Evaluation shall be done on the basis of delivered cost (i.e. total landed cost to BHEL, Haridwar). Metal rates of BME Copper Billet Prices and BME H.G. Zinc prices (IN THE RATIO OF COPPER AS 57.5% AND ZINC AS 42.5%) shall be taken prevalent of the enquiry issue date of tender (as mentioned above).

PVC for Billing:

- a. Lower of BME Copper Billet Prices and BME H.G. Zinc prices (IN THE RATIO OF COPPER AS 57.5% AND ZINC AS 42.5%), 30 days prior to the scheduled delivery date or actual delivery date shall be applicable for billing of PVC.
- b. BME Copper Billet Prices and BME H.G. Zinc prices (IN THE RATIO OF COPPER AS 57.5% AND ZINC AS 42.5%) shall be taken of the 30 days prior to the actual delivery date, in case material is received as per early delivery conditions mentioned in purchase order. In this case Serial no. (a) of PVC (for billing) shall not be applicable.

- Enquiry documents (GeM- ATC in line with standard model document set- [TOC Page No. 61-62](#)) are placed at [TOC Page No. 18-55](#) which shall be a part of the enquiry along with respective PQR & respective enquiry documents / formats.

Submitted for kind approval to invite open tender bids through "Custom Bid" option on GeM portal.

Approval of competent authority 'Engineer' empowered for inviting tender (Clause 2.1 of DOP) and for upfront declaration of conducting 'RA' (as per [SS&P Circular No. 08 of 2024-25 - RA Guidelines 2024 \(point no. 1\)](#)) is required to float open tender/custom bid on GeM portal as per Purchase policy 2013.
