- 1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 2. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. If the bidder wants to avail themselves of the

Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. - 4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 5. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

# 1.1 Technical Specification:

# 1.2 Quantity Tolerance:

# 1.3 Inspection & Testing at Suppliers Works:

BHEL reserves the right to inspect/test the material during/after manufacturing at su ppliers' works, and/or at BHEL Site as per BHEL/Customer's drawing/ field quality pla n. BHEL may get tested the material under dispatch from third party. The test results of third party test shall be final and binding on the vendor. In case of rejection at any stage, supplier shall be liable to replace the materials at his own cost.

MQP shall be arranged by vendor & get it approved from BHEL. However, delivery sc hedule should not be effected on account of MQP. BHEL will ensure approval of submi

tted MQP within 5 working days.

No material/equipment shall be dispatched by supplier unless and until Material Disp atch Clearance Certificate (MDCC) issued by BHEL/BHEL Site.

Bidder shall submit Copy of Test Certificate & Inspection Report signed by BHEL/TPIA for issuance of MDCC.

# 1.4 Delivery condition:

Suitable packaging along with proper dunnage shall be carried out. Loading shall be carried out on Wooden Logs placed above trailer bed to facilitate unloading Deliv ery Terms: F.O.R. Destination

**1.5 Test Certificate:** Material Test Certificate shall be provided to the consignee as required. Normally 3 Copies are required. If required additionally by BHEL, the same shall be provided without any additional cost.

## **Technical Specification of MS Gratings.**

### 2.1 Electro Forged Steel Gratings:

- 2.1.1 Factory made fabricated electro forged gratings unit with steel conforming to IS: 2062.
- 2.1.2 All grating units shall be rectangular in pattern and electro forged. The size and the spacing of the b earing bars and cross bars shall be as detailed in fabrication drawings. The contractor shall submit the grat ing design for different spans and load intensities along with fabrication drawings. (typical drags are attach ed for reference, the depth of the grating unit shall be 40, 32 & 25 mm (As per BHEL Sub POs), unless spec ified otherwise.
- 2.1.3 The gratings shall be made up in panel units designed to coincide with the span of the structural steel fra ming or openings as indicated in the design/ scope drawings. Maximum possible standardization of the grating panel sizes shall be tried and designed.
- 2.1.4 The grating unit shall be accurately fabricated and finished, free from wraps, twists, or any defects that wo uld impair their strength, serviceability, and appearance.
- 2.1.5 Grating work shall include cut outs and clearance opening for all columns, pipes, ducts, conduits or any o ther installation penetrating through the grating work. Such cut outs and clearances shall be treated as sp ecified in subsequent clauses.
- 2.1.6 The gratings shall be notched, trimmed and neatly finished.
- 2.1.7 Maximum deviation in linear dimension from the approved dimension shall not exceed 12mm.
- 2.1.8 All fabricated grating section and accessories shall be blast cleaned to near white metal surface (Sa 2 1/2 ) followed by Hot dipped galvanization at 610 gm/sq.m,
- 2.1.9 Prior to finishing all surfaces shall be cleaned, free from rust, mill scale, grease, oil, or any other foreign matter by blast cleaning. BS: 4232 shall be followed for blast cleaning.

### 2.2 Galvanization of Gratings

- 2.2.1 Purity of Zinc to be used-for galvanizing shall be 99.5% as per IS: 2 15
- 2.2.2 After the shop work is complete, the structural material shall be punched with erection mark and be hot double dip galvanized. Before galvanizing the steel section shall be thoroughly blast cleaned to near white metal surface (Sa 2 1/2)

- 2.2.3 The weight of the zinc coating shall be at least 610 gm/sq.m/ (as mentioned above) unless noted other wise.
- 2.2.4 The galvanized surface shall consist of a continuous and uniformly thick coating of zinc, firmly adhering t o the surface of steel. The finished surface shall be cleaned and smooth and shall be free from defects like discoloured patches, bare spots, unevenness of coating, spelter that is loosely attached to the steel, blister ed surface, flaking or peeling off etc. The presence of any of these defects noticed on visual or microscopic inspection shall render the material liable to rejection.
- 2.2.5 There shall be no flaking or loosening when struck squarely with a chisel faced hammer. The galvanized steel member shall withstand minimum four one minute dips in copper sulphate solution as per IS: 2633.
- 2.2.6 When the steel section is removed from the galvanizing kettle, excess spelter shall be removed by 'bump ing'. The processes known as 'wiping' or 'scrapping' shall not be used for this purpose.
- 2.2.7 Defects in certain members indicating presence of impurities in the galvanizing bath in quantities larger than that permitted by the specifications or lack of quality control in any manner in the galvanizing plant, s hall render the entire, production in the relevant shift liable to rejection.
- 2.2.8 All structural steel shall be treated with sodium dichromate or an approved equivalent solution after galv anizing; so as to prevent white storage stains.
- f the galvanizing of any member is damaged, the Engineer shall be shown of the extent of damage, if so directe d the galvanizing may have to the redone in the similar manner as stated above at no extra cost to the Ow ner

#### 2.3 Material Warranty

Free replacement of Step Tread Gratings in case of notification of defect in material within a period of On e year from the date of invoice. If defects observed after the delivery at site, the same shall be brought to the notice of the vendor by the BHEL site for the replacement, as the case may be, without any extra p ayment to the supplier.

Further, if the required quantity as per Original PQR is only o ne (1), then relaxed PQR shall also remain the same, (since quantity is non-divisible in this case.) ii. Other Technical Pre-Qualification requirements or any form of lice nses or requirements other than stated in Point no. i above, shall remain the same for all bidders.
- **(b) Financial Pre Qualifying Requirement (PQR) Turnover:** Financial pre-qual ifying requirements is relaxed by 50% of the original Pre –Qualifying Requirement specified in the tender (round off to the higher limit or number)."
- **7.** Conflict of Interest among Bidders/ Agents: A bidder shall not have conflict of interest with other

bidders. Such conflict of interest can lead to anti-competitive practices to the detrim ent of Procuring

Entity's interests. The bidder found to have a conflict of interest shall be disqualified. A bidder may be

considered to have a conflict of interest with one or more parties in this bidding process, if:
