OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 % of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

- **3.3. Submission of documents** (Drawing, Data sheet, QAP etc) To be submitted online within 15 days from the date of PO acknowledgement, for review and approval by BHEL/Customer. In case any comments issued, resubmission of revised document as require d, shall be submitted online after incorporating all the comments along with comment-resolution sheet, within 10 days from the date of issue of comments, for review and approval. The process continues till the final approval.
- **3.4. Post PO Documents Submission Delay Case:** In case there are delays in the submissio n of drawings, documents, data sheets, or quality plans beyond these specified days, those many days of delay by the bidder will be reduced from the delivery period mentioned in this GeM bid. Any delay in submission beyond the stipulated time will reduce the ultimate deliver v time.

- **3.5.** Approval required before manufacturing: (1) Approval of drawings, documents, and d ata sheets from BHEL Engineering. (2) Quality Plan approval from BHEL QC, and thereafter **e xplicit manufacturing clearance by BHEL.**
- 3.6. Manufacturing clearance: After issue of explicit manufacturing clearance by BHEL (mail or through online system) only, manufacturing shall be initiated. Manufacturing shall be as per the attached technical specification in the bid, approved drawing, quality plan, and data sheet. In the mutual interest of BHEL Ranipet and the bidder, the successful bidder on placement of the PO has to start manufacturing only after explicit manufacturing clearance from BHEL, which will be provided only after the approval of all applicable drawings and documents. If the bidder makes any investment/expense in manufacturing without obtaining explicit manufacturing clearance from BHEL, then the bidder will be solely responsible for the investment/expense. The bidder cannot claim any extra cost or damage charges from BHEL if manufacturing started without BHEL manufacturing clearance.

3.7. Delivery extension:

- a). If the delivery of supply as detailed above gets delayed beyond the delivery period, the Supplier/Vendor shall request for a delivery extension and BHEL at its discretion may exten d the Contract. However, if any 'Delivery extension' is granted to the Supplier/Vendor for c ompletion of supply, due to backlog attributable to the Supplier/Vendor, then it shall be wit hout prejudice to the rights of BHEL to impose LD for the delays attributable to the Supplier/Vendor.
- b). In case BHEL increase the quantity during currency of the contract in line with quantity variatio

n clause of GeM bid, delivery extension on pro-rata basis shall be given for supply of these additional quantity.

- **4. Post Manufacturing to Final inspection (Pre dispatch inspection) -** BHEL reserves the right to inspect the material during manufacturing and also to get tested the material under di spatch from third party. The test results of third party test shall be final and binding on the Su pplier/Vendor. BHEL will reserve the right to inspect/test the material during/after manufacturing at suppliers' works, and/or at BHEL Site. In case of rejection at any stage, Supplier/Vendor shall be liable to replace the materials at his own cost.
- **4.1.** Inspection call An inspection call should be raised by the supplier in the BHEL CQIR port all in advance of **3 (three) days** before the actual date of the requirement for inspection thr ough the website (https://cqir.bhel.in /). If the bidder is a first-time supplier to BHEL, he has to register himself on the portal to be able to offer an inspection request. - 4.2. Inspection Online allocation of inspector shall be taken care by system. Joint inspection applicable as per categorisation plan inline with quality terms. Inspection shall be conducted by BHEL/Authorised Inspection Agency (TPI-Third Party Inspection) and end customer/NTPC/o thers (joint inspection, if applicable) before despatch at the supplier's works (as per quality t erms and quality plan). Inspection includes painting and packing, as applicable. While biddin g, the bidder should consider 7 (seven) days for inspection from the date of inspection call-raising on the BHEL CQIR portal for inspection. Any delay in inspection beyond 7 (seven) day s shall be on the part of the buyer. After the completion of the inspection, all the documents related to testing and inspection should be submitted to BHEL-Ranipet for review and dispatch clearance.
- **4.3. PDI cost and duration** Travel and other local stay cost for the inspectors sent by BHEL will be to BHEL account, but other inspection charges, if any, shall be to the account of the s ellers only. For in-house testing, the sellers will provide necessary facilities at free of cost. An y delay in inspection beyond 7 days shall be on the part of the buyer.
- **4.4. After successful inspection** (material acceptance by TPI as per cqir report) All the Test and inspection reports shall be sent to BHEL-Ranipet for review and Packing clearance. In ca se of stage inspection, or rejection, fresh inspection call to be raised. The process continues t ill the final acceptance. 5. Post inspection phase - Packing to dispatch
