Only those who are technically and financially capable to execute the Job and who fulfil the Qualifying requirements [QR] given under are eligible to quote against the above NIT. Tenderers should submit their offer in a sealed envelope as per the procedure specified in tender documents. The minimum QR of contractor for tender submission shall be as under:

- a) Vendors should have a minimum average annual turnover of. **Rs 60 Lacs** and should submit audited balance sheet and Profit & Loss Account for last three years (2005-06, 2006-07 & 2007-08)
- b) Vendor should have successfully executed/ executing ETC work of at least one complete substation of 132 kV substation or above rating during last seven year ending on 31.07.09. Vendor should produce Certification/proof in support of execution/executing similar package from User/end user.
- c) Vendor should have earned profit in at least one year during last three financial years (2005-06, 2006-07 & 2007-08)
- d). The contractor should meet the minimum QR for T&P and testing equipments as per Annexure-I.
