Tenderers should submit their offer in a sealed envelope as per the procedure specified in tender documents. The QR of contractor for tender submission shall be as under:

**A.** Vendors should have a minimum average annual turnover of. **Rs.45 lacs** and should submit audited balance sheet and Profit & Loss Account for last three years (2006-07, 2007-08 & 2008-09)

**B.** Vendor should have successfully executed/executing similar job (**ref note 1 below**) during last seven years ending 31.10.09. Vendor should produce certification/proof in support of execution/executing similar package from user/end user and should be either of the following:

**i. Three similar completed/ executing works costing not less than Rs. 55 lacs.**

OR

**ii. Two similar completed /executing works costing not less than Rs. 70 lacs.**

OR

**iii. One similar completed/ executing work costing not less than Rs. 115 lacs**

**C.** Vendor should have earned profit in at least one year during last three financial years (2006-07, 2007-08 & 2008-09)

**NOTE:**

- 1. Similar job shall mean successful executed/executing of civil works of switchyard or substation or power house or industry /infrastructure predominantly concrete work.**
