**SUB: TENDER FOR EXECUTION AND HANDING OVER OF CIVIL WORKS OF PRE CAST CABLE TRENCH COVER AT 400 KV SWITCHYARD AT ANDAL SITE OF DVC IN WEST BENGAL.**

Sealed Tenders (Under two part bid system) are invited from competent civil contractors for execution and handing over of civil works of Pre Cast Cable Trench Cover at 400 kV Switchyard at Andal site of DVC in West Bengal. Only those who are technically and financially capable to execute the Job and who fulfil the Qualifying Requirements [QR] given under are eligible to quote against the above NIT. Tenderers should submit their offer in a sealed envelope as per the procedure specified in tender documents. The QR of contractor for tender submission shall be as under:

**A.** Vendors should have a minimum average annual turnover of **Rs.10 lacs** and should submit copy of audited balance sheet and Profit & Loss Account for the last three years (2007-08, 2008-09 & 2009-10). In case audited balance sheet is not available due to turnover being less than statutory requirement of audit, bidder should furnish self certified copies of Balance Sheet, Profit & Loss account alongwith certificate from C.A. in support of certification of Turn Over.

**B.** Vendor should have successfully executed/executing similar job (**ref note 1 below**) during last seven years ending 30.06.11. Vendor should produce certification/proof in support of execution/executing similar package from user/end user and should be either of the following:

**i. Three similar jobs executed costing not less than Rs. 13 lacs each**

OR

**ii. Two similar jobs executed costing not less than Rs. 17 lacs each.**

OR

**iii. One similar jobs executed costing not less than Rs. 27 lacs each.**

**C.** Vendor should have earned profit in at least one year during last three financial years (2007-08, 2008-09 & 2009-10)

**NOTE:**

**1. Similar job shall mean successful executed/executing of civil works of switchyard or substation or power house or industry /infrastructure predominantly concrete work.**

### **Important Notes**

- 1) BHEL reserves the right to:
  - (a) Accept or reject any bid received at its discretion without assigning any reasons whatsoever.
  - (b) Postpone the above mentioned date, split and distribute the work among more than one bidder without assigning any reason whatsoever.
